## **REVIEW OF SPECIALTY PRODUCTION AND NEW ENTRANT PROGRAMS – IMPROVING ACCESS TO THE SUPPLY MANAGEMENT SYSTEM**

On September 1 and 2, 2005, the British Columbia Farm Industry Review Board (FIRB) issued general directions to the five supply managed commodity boards in British Columbia. These directions followed a two year review by FIRB and the Ministry of Agriculture and Lands (the Ministry) concerning how specialty production, new entrant and quota programs were to be administered by the five boards.

The boards were required to draft orders in compliance with the general directions and submit their orders to FIRB for review and prior approval before implementation. Interested persons were also provided opportunity to provide written submissions with respect to the draft orders.

On October 31, 2005, the British Columbia Broiler Hatching Egg Commission (Commission) submitted its draft orders to FIRB. FIRB reviewed those orders (no submissions in response to the draft orders were received) and wrote to the Commission requiring changes be made to certain provisions in the orders and seeking clarification with respect to other provisions. Subsequently the Commission made those changes and provided the requested clarification.

At its meeting of February 8, 2006, FIRB gave further consideration to the provisions of the Commission's orders relating to new entrants and quota transfers. FIRB determined that it would prior approve these provisions effective the date of this letter based on the following understandings.

First and foremost, Commission allocation policies and decision-making are expected to be in accordance with the Ministry's "Regulated Marketing Economic Policy" and FIRB's September 1, 2005 directions. This includes being responsive to specialty, niche and other innovative marketing opportunities when the need for those become evident in the B.C. hatching egg industry.

Second, while FIRB is generally satisfied that the present orders are in compliance with the policy expectations outlined in the September 1 and 2, 2005 directions, it also recognizes that certain details will be the subject of ongoing dialogue and review, and that adjustments may still need to be made based on practical experience gained in applying and managing the orders. Recognizing the significant input and expertise that has informed the policy judgments reflected in these orders, regulatory changes of this nature necessarily require regulators to monitor, on an ongoing basis, whether and to what extent the proposed changes are achieving their policy objectives, and requires them to consider adjustments and amendments as appropriate.

FIRB requires the Commission to be proactive and timely in responding to issues that emerge from the implementation of its new orders. In responding to these issues and the potentially differing points of view and interpretations of the orders, the Commission must act progressively, fairly, transparently and equitably. This is particularly important in the administration of the Commission's new entrant list and new entrant program.

In accordance with the September 1, 2005 directions, FIRB will continue to monitor developments as the new orders are implemented. This monitoring will include continued dialogue between FIRB and the Commission respecting these orders and concerning issues that may arise.

There will be performance expectations flowing from memoranda of understanding between the Minister of Agriculture and Lands, the chair of FIRB and the chairs of the five supply managed boards. FIRB will also conduct a formal review of all programs in three years time.

FIRB acknowledges and appreciates the effort and careful thought that the members and staff of the Commission have put into the development of their orders. The Specialty Review has been a challenging task and FIRB appreciates the contributions you have made to the process.
