GOVERNMENT LOSS REPORTING

Risk Management Branch and Government Security Office

Risk Management Branch and Government Security Office is the central government agency accountable for the management of risk to which the government is exposed to by virtue of its assets, programs and operations. Centralized reporting provides an understanding of what numbers and types of losses or incidents are being encountered based on reported incidents.

Loss reporting related to 'Workers' Compensation' or 'Fleet Vehicles' normally falls outside this format. If, however, a loss arises from a crime or threat-related incident, then reporting is appropriate as part of a follow-up security review (e.g. assault, robbery, vandalism, theft).

Note: over time, several overlapping variables have impacted reporting. For example:

- The number of ministries across government has been subject to change.
- Some program areas have been realigned between ministries.
- Policy has been revised to provide greater clarity and consistency for reporting.
- A web-based tool was implemented to standardize and facilitate reporting.
- There is additional emphasis now on the need to report some incident types (privacy breaches, threats of violence, fraud).

Crown Loss and Recovery Reporting

Fiscal 2019 (April 1, 2019 to March 31, 2020)

Forest Act Section 105.1

• One determinations made under Section 105.1 under the Forest Act for an "individual" or Licensee. The penalty amount was \$6,625

Forest and Range Practices Act Section 52 Determinations and Penalties.

• Five determinations made under Section 52 (Casefile number is repeated as different sections of the statute was listed ie. 52(1) and 52(3), as well our enforcement platform doesn't separate out the estimated losses between the two sections, so I divided them in half). All five received a penalty. Penalty totals were \$143,513.26 and the total estimated loss of volume was 16,570.14m3. However, the Crown was made whole through administrative penalties

Forest and Range Practices Act (Other than Section 52):

- Two determinations were made under sections 46, and 57 of FRPA (there were no determinations Section 22 and 51 of FRPA or any under the Forest Act). There were no loss to the Crown and penalty amounts were \$3,700.00.
- The total amount of penalties was \$147,213.26

Forest and Range Practices Act Violation Tickets Loss and Penalties (S.52 of FRPA):

 54 Violation Tickets were issued under Section 52 of FRPA for an estimated loss of 25,288.66m3. The Total Violation Ticket Amount is \$9,515

Losses under other Acts/Sections:

 192 other records were reviewed such as the Water Sustainability Act, Land Act, and Off Road Vehicle Act etc. and there were no losses to Crown or any recovery.
