Title: 2021 PSO Climate Change Accountability Report

Organization name: School District 70 Pacific Rim

Declaration statement: This Climate Change Accountability Report for the period January 1, 2021 to December 31, 2021 summarizes our emissions profile, the total offsets to reach net-zero emissions, the actions we have taken in 2021 to reduce our greenhouse gas emissions and our plans to continue reducing emissions in 2022 and beyond.

Overview: School District 70 has continued to make strides in reducing greenhouse gas emissions. From the CNCP's launch School District 70 has reduced its Total Emissions by almost 50% (from 1832.95 tonnes in 2011 to 920 tonnes in 2021). SD70 slightly reduced emissions in 2021 over 2020 (920 tonnes vs 927 tonnes) which is commendable considering energy consumption was increased due to maximized HVAC ventilation in order to improve school air quality regarding COVID-19. Over the past 5 years School District 70 (Alberni) has upgraded HVAC systems and building envelopes in 5 facilities and moved 2 facilities from heating oil to propane driving even further reductions in emissions.

We continue to embrace energy conservation measures and constantly maintain environmental consciousness as buildings are renovated, retrofitted and decommissioned as well as continuing to complete as many upgrades to insulation, lighting, mechanical and control systems as we can, within our budget constraints. We continue to pursue projects designed to reduce emissions through the Carbon Neutral Capital Program and continuously review our practices with an eye to reducing emissions at every opportunity.

We are committed to improving learning for all students. This includes raising awareness around environmental issues and educating staff and students to be good "Global Citizens". District wide students and staff engage in many initiatives:

- reducing waste output
- car-pooling programs
- actively recycling
- composting
- purchasing green products
- undertaking energy challenges
- turning off / unplugging unneeded equipment and lights
- promoting sustainability through Project Based Learning

As always, environmental effects and benefits continue to be considered in all our decisions and practices.

- ii. Emissions and offset investment amounts will be validated by CAS prior to distributing invoices.

Retirement of Offsets: In accordance with the requirements of the Climate Change Accountability Act and Carbon Neutral Government Regulation, School District 70 pacific Rim (the Organization) is responsible for arranging for the retirement of the offsets obligation reported above for the 2021 calendar year, together with any adjustments reported for past calendar years (if applicable). The Organization hereby agrees that, in exchange for the Ministry of Environment and Climate Change Strategy (the Ministry) ensuring that these offsets are retired on the Organization's behalf, the Organization will pay within 30 days, the associated invoice to be issued by the Ministry in an amount equal to \$25 per tonne of offsets retired on its behalf plus GST.
