## Important Updated Information on Ebola Virus Disease (EVD) for BC Physicians

Preparedness efforts to deal with any potential case of EVD in BC have been underway for several months now and three individuals who returned to BC from Ebola affected countries in West Africa have been tested for EVD. All were negative and there have been no EVD cases in BC or Canada to date. However, as long as the outbreak continues in Sierra Leone, Guinea and Liberia, there is potential for returning healthcare workers and other travelers to develop the disease in BC as recently occurred with a Scottish nurse who became ill on return to the UK.

Recent events around assessment of at risk patients for EVD have tested these protocols and identified where additional guidance is needed. For the most part, however, these protocols have worked well and allowed for safe and efficient assessment, testing, care and management of patients. These protocols were developed so we can provide the best possible support to patients in a way that protects the safety of our healthcare workers and facilities in BC. We expect that all physicians will be familiar with them and follow them. If in any doubt or if you have any concerns about possible Ebola in a patient **contact your local Medical Health Officer (MHO) immediately** (see contact information below). The MHOs in BC are up to date on the latest information about EVD and will provide you with risk assessment support and guidance on safe management of your patient.

If you should assess a patient as being at risk or are considering EVD in a differential diagnosis, please contact your local MHO for a risk assessment and advice on how to proceed. Do NOT send the patient away to an Emergency Department or community laboratory with an EVD test requisition.

We have had 18 people, mostly healthcare workers, who have returned to BC from the affected countries in West Africa to date and we know of more who will be going to assist in the response in those countries over the coming months. We will be dealing with the low, but real, possibility of one of these people developing EVD or, more likely, a febrile illness for which we need to rule out EVD for at least the next year. To be prepared to do this safely and effectively all physicians in BC need to understand their role and the protocols in place.
