Declaration statement: This PSO Climate Change Accountability Report for the period January 1, 2021 to December 31, 2021 summarizes our greenhouse gas (GHG) emissions profile, the total offsets to reach net-zero emissions, the actions we have taken in 2021 to reduce our GHG emissions, and our plans to continue reducing emissions in 2022 and beyond.

Emission Reductions: Actions & Plans

A. Stationary Sources (e.g. buildings, power generation)

- Preparation and procurement for additional controls to heating boiler, linking heating water temperatures to OAT instead of preset setpoint, with expected decrease in gas GJ usage. (note – work completed in February 2022)
- Preparation and procurement for lighting retrofit to upgrade 4th and 5th floors and other selected areas of the facility to LED lighting, with expected decrease in power usage (note – work completed between January and March 2022)
- Preparation and procurement for domestic hot water system upgrade from gas fire tanks to modulated condensing boiler. (note – project to commence July 2022)

B. Mobile Sources (e.g. fleet vehicles, off-road/portable equipment)

- Preparation and procurement for electrical upgrades to be able to support future expansion including e-charging stations
- No fleet vehicle usage throughout 2021

C. Paper Consumption

- Use of recycled paper for printing/photocopiers
- Implementation of awareness program for staff to help reduce paper usage
- Implementation of electronic work order system, eliminating paper work orders
