AMENDMENT

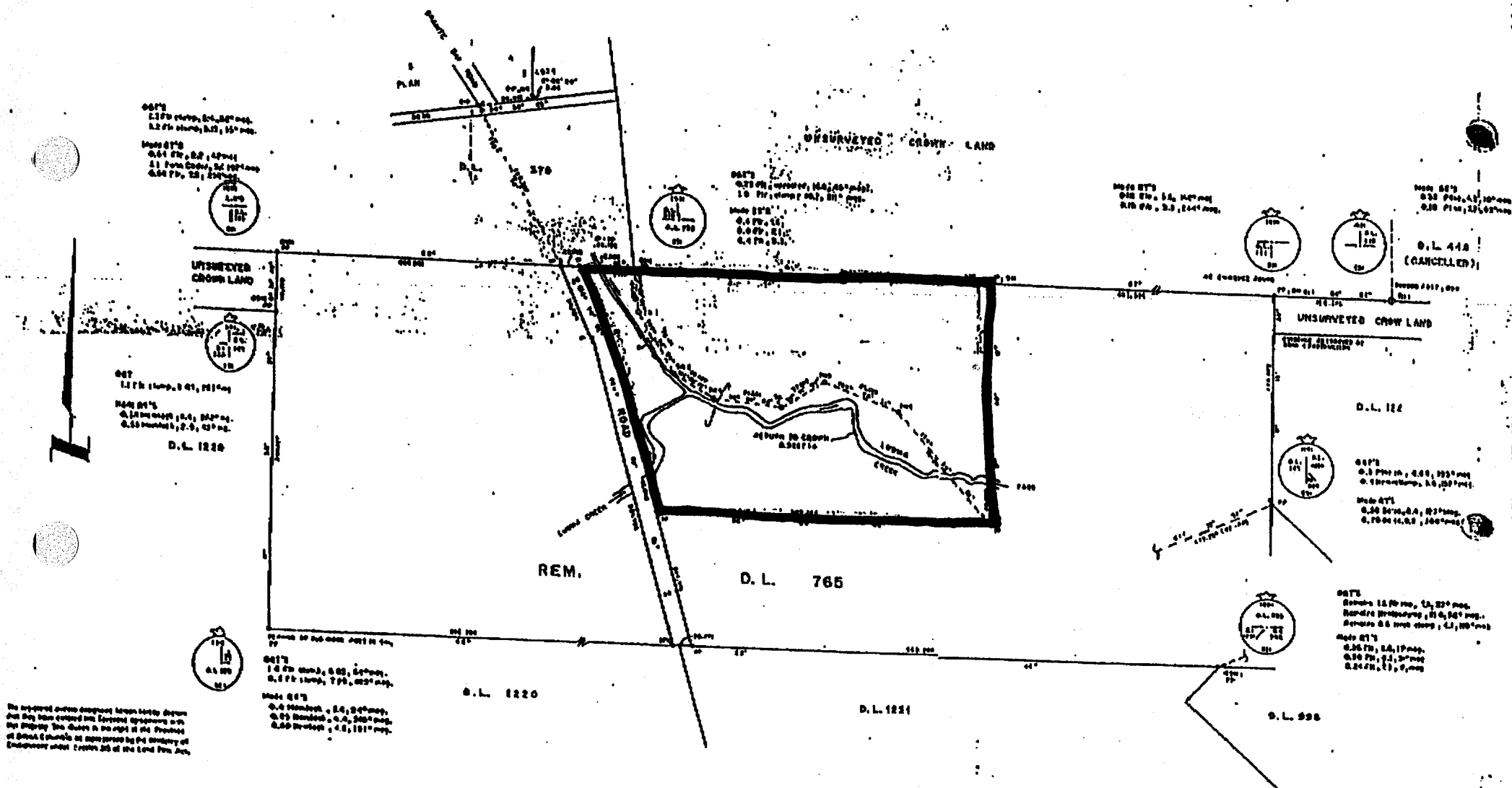

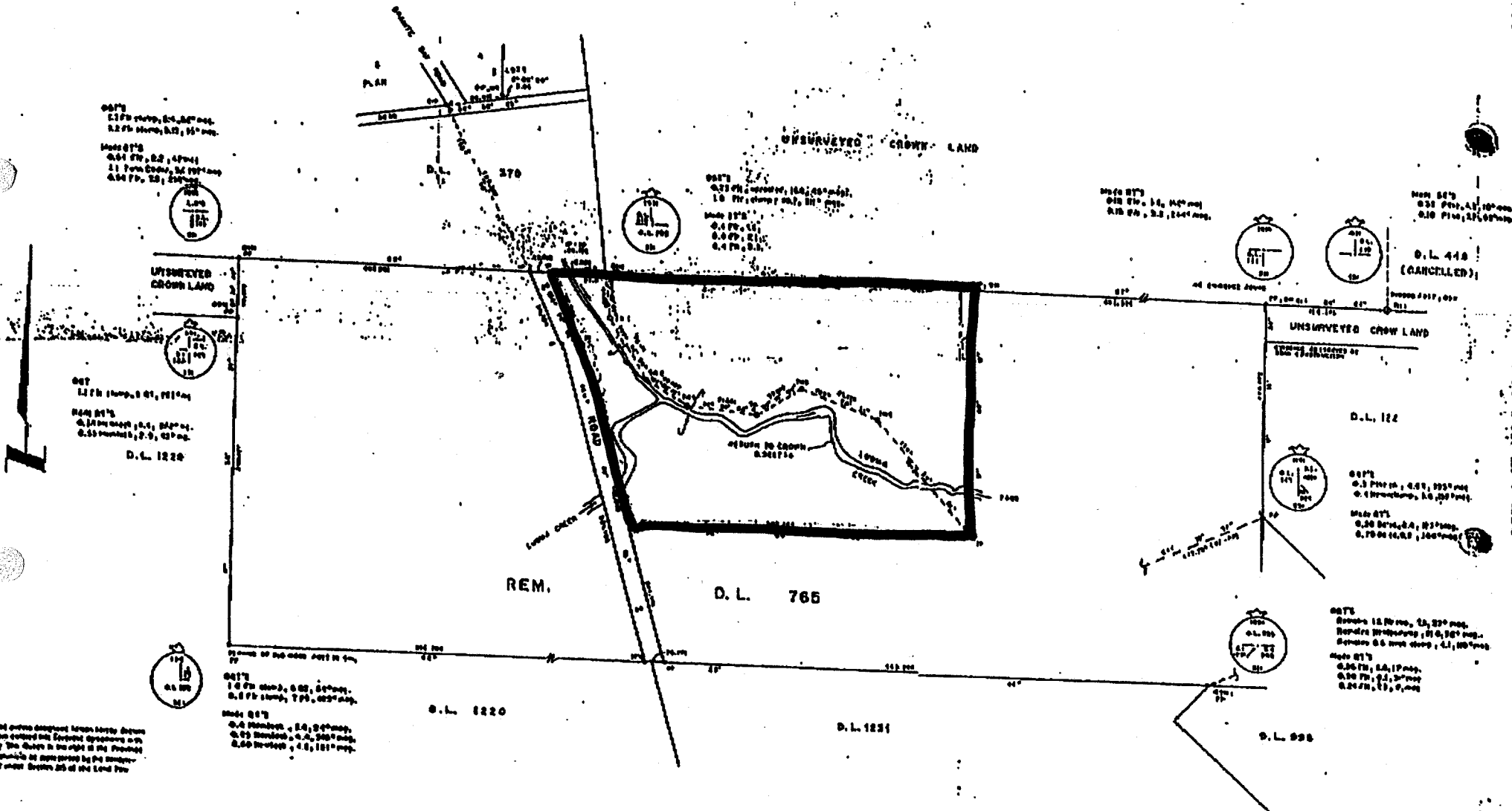

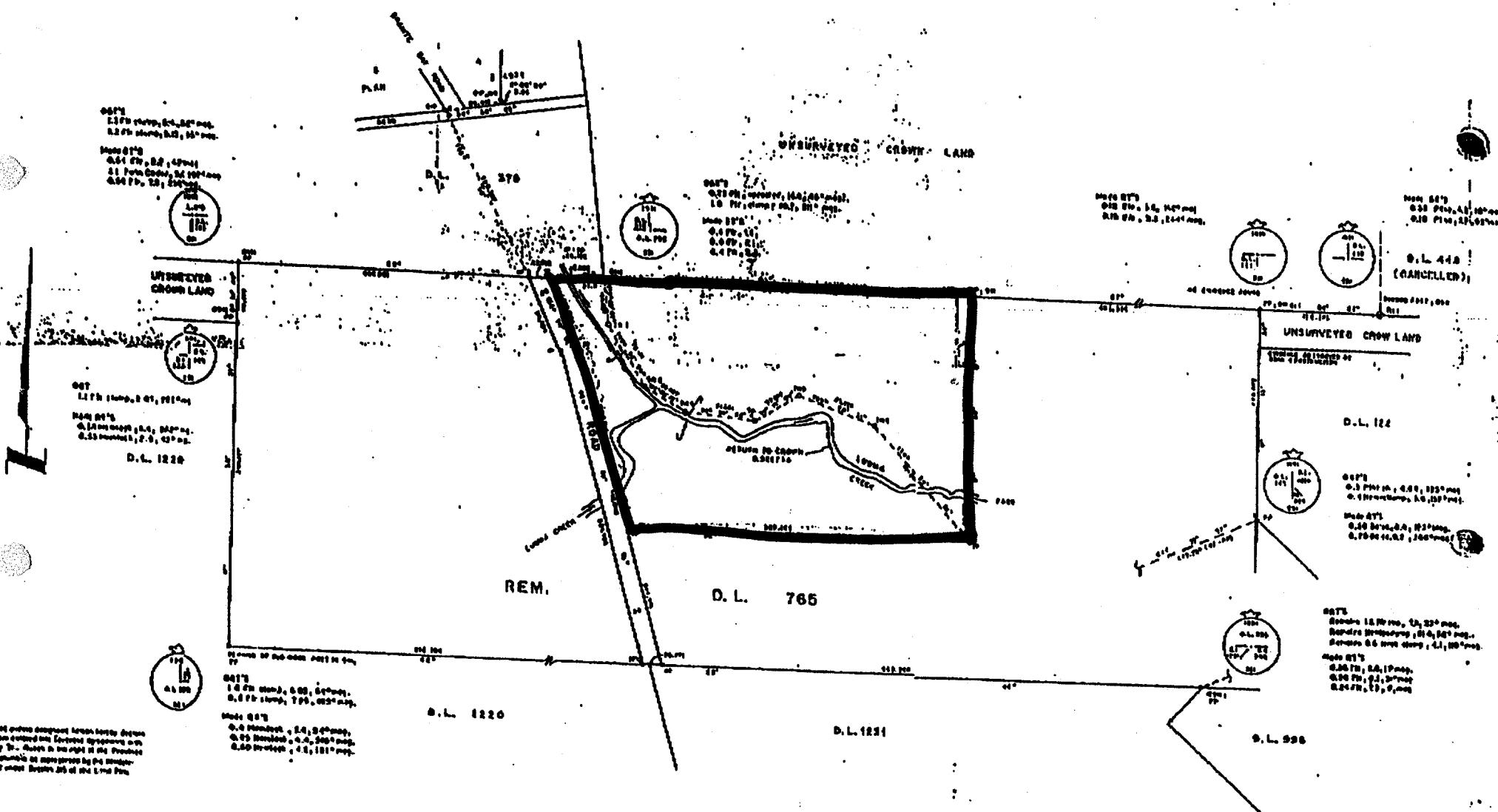
