The Sheriff took charge of the jury and recorded 5 exhibits. 13 witnesses were duly sworn in and testified.

PRESIDING CORONER'S COMMENTS:

The following is a brief summary of the circumstances of the death as presented to the jury at the inquest. The summary and my comments respecting the recommendations, if any, are only provided to assist the reader to more fully understand the Verdict and Recommendations of the jury. This summary is not intended to be considered evidence nor is it intended in any way to replace the jury's verdict.

On the evening of August 27, 2007, Mr. Larry McPherson was observed by his roommate using both cocaine and alcohol. The roommate stated that Mr. McPherson had suffered from paranoia when he had used cocaine on previous occasions.

At approximately 0050 hours of August 28, 2007, a man, later identified as Mr. Larry McPherson, was seen running from a motel by a local private security guard. Mr. McPherson was yelling for help, but ran away from the security guard when he attempted to offer assistance.

Royal Canadian Mounted Police (RCMP) Dispatch received a call of a disturbance by the Grand Hotel. Two Fort St. John RCMP members, while in separate marked police cruisers, located Mr. McPherson on 100th Street. While in his police cruiser, one member noted that Mr. McPherson had large rocks in either hand. This Constable directed him to drop the rocks and he complied.

When the Constable exited his cruiser, Mr. McPherson started to walk away in the direction of the second RCMP member. At this time, he demanded to see badges proving they were RCMP members. Both members noted this was an odd request as they were in marked police cruisers when they arrived. At this point, Mr. McPherson started to run away as he was being advised he was under arrest for Mischief,

The two Constables followed after Mr. McPherson and were able to get him to the ground. Subsequently, three other members of the RCMP attended the scene and they attempted to place him into a police cruiser while he continued to actively resist.

While transporting him to the vehicle, Officers noted Mr. McPherson had become unresponsive so he was placed back on the ground and the British Columbia Ambulance Service (BCAS) was called. Soon after being placed on the ground, Mr. McPherson appeared to start "seizuring" so he was placed in the recovery position awaiting the

arrival of BCAS staff. After a brief time Mr. McPherson appeared to regain consciousness and he started to fight with RCMP members again.						
BC Ambulance personnel arrived at 0111 and witnessed RCMP members attempting to restrain Mr. McPherson who was exhibiting a great amount of strength and energy in continuing to fight. Mr. McPherson once again became unresponsive and BCAS personnel moved him to a stretcher where they performed CPR. They then proceeded to transport Mr. McPherson to Fort St. John General Hospital.						
At 0129 hours BCAS arrived at the hospital with Mr. McPherson. Further attempts at resuscitation were made without success. At 0215 hours of August 28, 2007, Mr. Larry McPherson was pronounced dead.						
Toxicological testing indicated that Mr. McPherson was intoxicated by cocaine and influenced by a low level of alcohol at the time of his death.

Coroner's Comments: The jury heard evidence that British Columbia Ambulance Service personnel were not aware of the nature of Mr. McPherson's medical condition prior to their arrival.

2. Funding and resources be provided to raise awareness and provide resources to children with learning disabilities.

Coroner's Comments: The jury heard evidence that Mr. McPherson suffered from learning disabilities and was unsuccessful in school as a result. This difficulty in school started a string of behavioural problems that led to his subsequent use of illicit drugs as a means of self-medicating.
