On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that

- 1. B.C. Regs. 448/83 and 450/83 be repealed.
- 2. The following described lands in the Skeena Mining Division, Queen Charlotte Land District, are established as a mineral reserve and as a placer mining reserve until August 31, 1986.

Commencing at a point on the natural boundary of Lyell Island on the Northeast shore thereof, said point being due North 1350 m, more or less, and due West 900 m of the Ful Hydrographic Triangulation Station; thence in a general Southeasterly, Southerly and Southwesterly direction along the said natural boundary of Lyell Island to a point due South 4550 m, more or less, and 350 m due West of a point on the natural boundary of Lyell Island being due North 1350 m, more or less, and due West 900 m of the Ful Hydrographic Triangulation Station; thence due North to the natural Southerly boundary of Windy Bay Creek watershed; thence in a general Westerly, Southwesterly, Northerly Northeasterly, and Easterly direction along the natural boundary of Windy Bay Creek watershed to a point due South 100 m, more or less, of the Southeast corner of District Lot 1940, Queen Charlotte Land District; thence due North to the Southeast corner of the said District Lot 1940; thence Westerly along the Southerly boundary of the said District Lot 1940 and the prolongation thereof to the natural boundary of Lyell Island; thence in a general Northerly, Easterly and Southeasterly direction along the natural boundary of Lyell Island to a point due north 1350 m, more or less, and due West 900 m of the Ful Hydrographic Triangulation Station, being the point of commencement.
