THEREFORE:

In accordance with Section 39.1(2)(b) of the *Forest Act*, the Licensor, with the consent of the Licensee, hereby changes the area of Tree Farm Licence 44 by removing the private lands subject to the Tree Farm Licence agreement.

The Licensor and the Licensee agree that Schedule A to the Tree Farm Licence 44 agreement is hereby amended by deleting the private lands.




