SUBJECT: Resumption of the Petroleum and Natural Gas Tenure Disposition Process

Following the pause in petroleum and natural gas tenure dispositions in response to COVID-19 earlier this year, the Ministry of Energy, Mines and Low Carbon Innovation is resuming the monthly tenure disposition process.

Notice is given that the Ministry of Energy, Mines and Low Carbon Innovation will hold dispositions for the right to explore and develop Crown petroleum and natural gas resources in British Columbia on the dates identified below. This notice supersedes Information Letters OGD-19-01 and OGD-20-02.
