ORDER OF THE MINISTER OF FORESTS, LANDS, NATURAL RESOURCE
OPERATIONS AND RURAL DEVELOPMENT

Forest and Range Practices Act

Ministerial Order No. M77

I, Katrine Conroy, Minister of Forests, Lands, Natural Resource Operations and Rural Development, pursuant to sections 7 (1) and (2) of the Government Actions Regulation (GAR), order that:

- a) scenic areas and Visual Quality Objectives (VQOs) on Lasqueti Island, which were established through a district manager's letter, dated May 16, 1997, under the provisions of the Operational and Site Planning Regulation, are cancelled;
- b) scenic areas in the vicinity of Mt Wesley, which were established through a district manager's letter dated November 13, 1998, and VQOs, which were established under the South Island Forest District VQO GAR Order, dated December 15, 2005 and subsequent amendment dated December 30, 2011, are cancelled;
- c) scenic areas and VQOs for Lasqueti Island are established as set out in the map attached as Schedule A; and
- d) scenic areas and VQOs for Mt Wesley region are established as set out in the map attached as Schedule B.

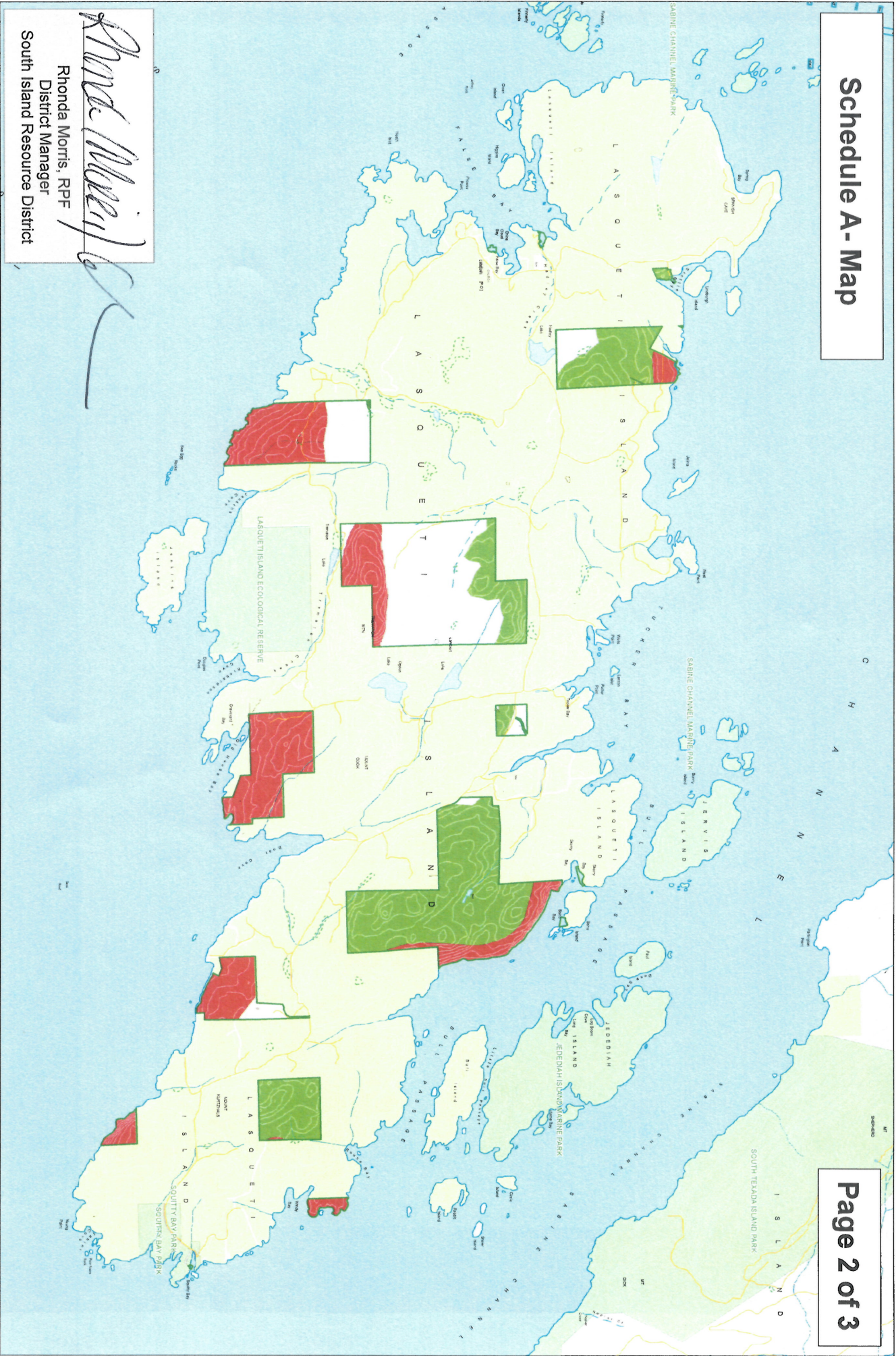

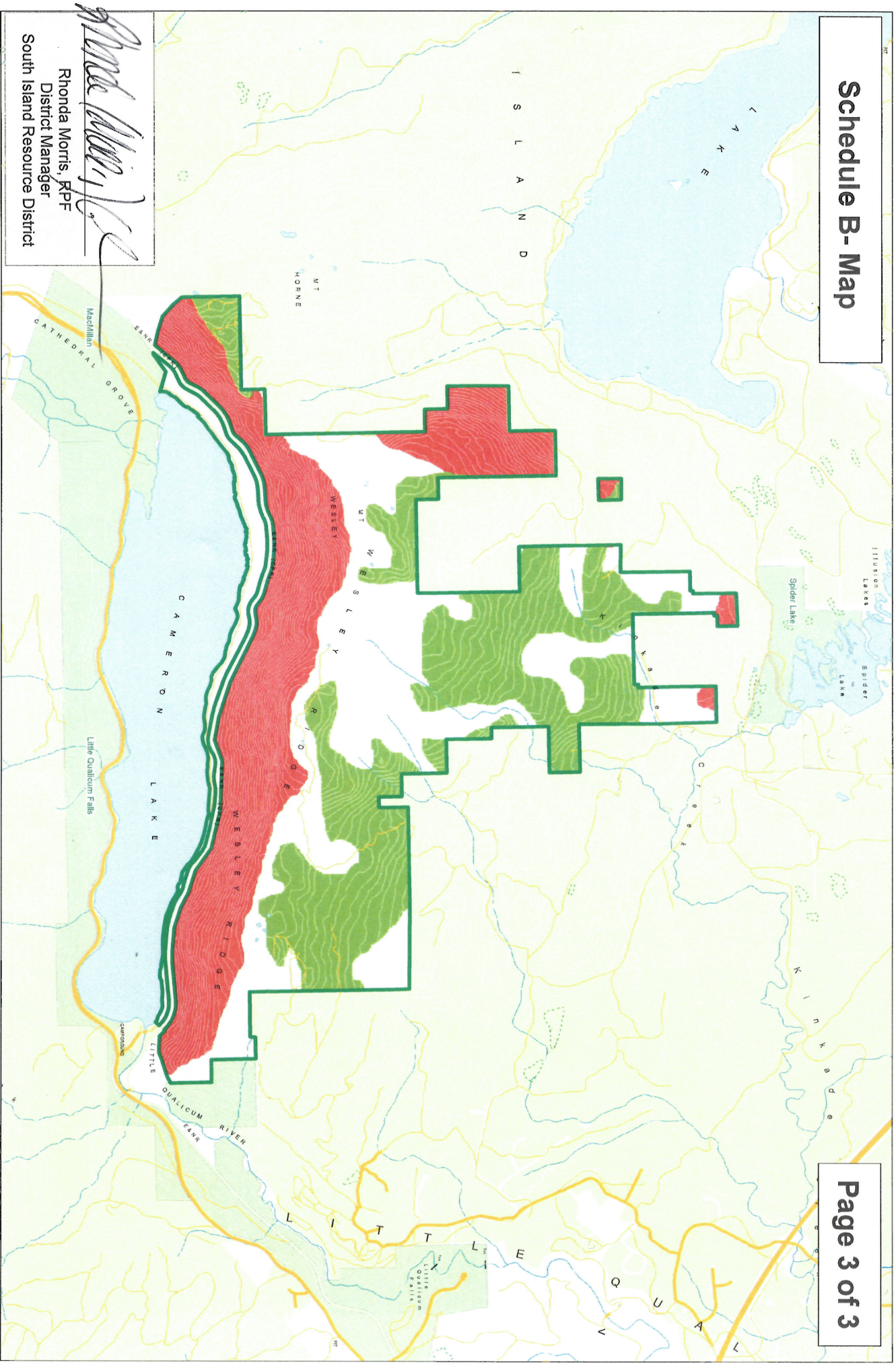
