## MPL BRITISH COLUMBIA DISTRIBUTORS INC. (MPL BC) AGENCY PRIOR APPROVAL PROCESS – SUPPLEMENTAL WRITTEN SUBMISSIONS

The British Columbia Farm Industry Review Board (BCFIRB) is currently deliberating on the MPL BC agency designation prior approval.

The March 8, 2023 "Final Terms of Reference Prior Approval Application: MPL British Columbia Distributors Inc. Agency Designation" (Terms of Reference), provided that BCFIRB would:

"...take into consideration the January 25, 2023 ruling of Chair Peter Donkers made in the Allegations of Bad Faith and Unlawful Activity supervisory review, and will seek written submissions on that ruling, including implications of the voluntary reporting requirement agreed to by MPL BC" (which were attached to the Terms of Reference as Appendix A).

We have attached as Appendix A Chair Donkers January 25, 2023 ruling made in the Allegations of Bad Faith and Unlawful Activity supervisory review (the Ruling). To date, only the BC Vegetable Marketing Commission (Vegetable Commission) has been asked to comment on the voluntary reporting requirements in the prehearing questions. We have also reviewed the closing submissions of the Vegetable Commission, MPL BC and Greenhouse Grown Foods Inc./Windset Farms (Canada) Ltd. (GGFI/Windset), and note that there are only limited comments on the Ruling.

Accordingly, all eligible participants<sup>1</sup> are invited to make a supplemental written submission on the implications, if any, of the Ruling on the designation of MPL BC as an agency, including implications of the voluntary reporting requirement agreed to by MPL BC.

Any supplemental written submissions are **due by August 25, 2023**. Final replies from MPL BC and the BC Vegetable Marketing Commission are **due by August 30, 2023**.
