2. ESTABLISHMENT OF KDPL FUND (OSPREY)

In 2016 the Kaslo & District Public Library Association has established 'The Kaslo & District Public Library Fund' with the Osprey Foundation with an original donation of \$10,000 from a bequest.

3. KASLO COMMONSPACE FEASIBILITY STUDY

The Kaslo Commonspace Feasibility Study (March to October, 2018) was funded by Columbia Basin Trust. A committee consisting of Library Board members and representatives from Selkirk College and North Kootenay Lake Community Services Society worked with Cover Architectural Collaborative, Inc. on this feasibility study. The Kaslo & District Public Library took the lead in managing the grant funding and partner contributions for this Feasibility Study on behalf of the committee members. The goal of this study was to understand current and future needs of each partner and examine two site options including the Kemball Memorial Centre for developing a joint facility that would include shared spaces. Phase one of this project is complete.
