NEW REIMBURSEMENT COMES INTO EFFECT APRIL 1, 2013



As announced in <u>PharmaCare Newsletter 13-002</u>, new Low Cost Alternative/ Reference Drug Program and Pan-Canadian reimbursement changes take effect on **April 1, 2013**.

INSULIN PUMPS NOW COVERED UNDER PHARMACARE PLAN F

Insulin pumps are now a benefit under PharmaCare Plan F (Children in the At-Home Program). Insulin pump supplies were and continue to be a benefit for patients on Plan F.

Patients on Plan F must still meet the established criteria for coverage of insulin pumps as detailed in the PharmaCare Policy Manual, <u>Section 5.17</u>.

PHARMACARE BECOMES FIRST PAYER FOR RCMP

Effective **April 1, 2013**, PharmaCare will become first payer for B.C. members of the RCMP. RCMP members will be subject to the same requirements for eligibility—and receive the same plan coverage—as other British Columbians. Extended health benefits for members of the RCMP will continue to be provided through their usual private insurer.



Please note: PharmaCare is not the first payer for other federally covered patients, including those covered under Veterans Affairs Canada, the Canadian Forces, or the Non-Insured Health Benefits Program.

Claims submitted after April 1, 2013, at 6 a.m. will automatically adjudicate with PharmaCare as the first payer.

Please note the following when submitting claims for RCMP members:

Scenario	Result	Action Required
Claims submitted before April 1 that are reversed on or after April 1	PharmaNet will respond with the message NO REVERSAL MADE—ORIG. CLAIM MISSING.	None. The message simply indicates that the original claim was not adjudicated under PharmaCare.
Claims submitted between 12 a.m. and 6 a.m. on April 1	If your pharmacy submits a claim for an RCMP member after the new policy takes effect (12 a.m. April 1) but before PharmaNet is fully updated, the claim may not adjudicate to PharmaCare.	If a claim does not adjudicate under PharmaCare during this 6-hour timeframe, reverse the claim and re-enter it after 6 a.m. on April 1. You will receive the error message above, which can be safely ignored.

PharmaCare Plan D (Cystic Fibrosis) Formulary Update

Effective **March 18, 2013**, the Ministry, in collaboration with the Cystic Fibrosis stakeholders, has updated the Cystic Fibrosis formulary. Individuals with cystic fibrosis who are registered with one of the province's four cystic fibrosis clinics receive coverage of digestive enzymes and other products listed in the Cystic Fibrosis formulary.

Important: Products listed in the Cystic Fibrosis formulary are eligible for coverage under Plan D only if they are purchased at a pharmacy in the same manner as prescription drugs. Plan D coverage is not available to patients in acute or extended care hospitals.
