## INDUSTRY STABILTY AND CURRENT PRICING STRUCTURES – COMMODITY BOARD OPPORTUNITY TO RESPOND TO SUBMISSIONS

On July 8, 2021, the BC Farm Industry Review Board (BCFIRB) supervisory panel on chicken sector pricing advised that it would review the Interim Order it gave in July 2020 with respect to chicken pricing given: the passage of time; a long-term pricing outcome will not be reached until fall 2021; the changes to the Ontario Cost of Production Formula; and the Primary Poultry Association of BC (PPPABC) concerns about the stability of current pricing structures.

The goal of the Interim order was to ensure industry stability and orderly marketing while longer-term pricing solution discussions were underway.

The PPPABC, the BC Chicken Growers Association, the BC Hatching Egg Producers Association, and the BC Egg Hatchery Association were invited to make submissions. Submissions were received from the PPPABC and the BC Chicken Growers Association. Both submissions are attached.

The BC Chicken Marketing Board and the BC Broiler Hatching Egg Commission are now asked to respond to these submissions. These responses from each board will need to include:

- How the positions, concerns and examples raised in the submissions from the PPPABC and the BC Chicken Growers' will be assessed and addressed around market and industry instability;
- The Board position about how one or more of the current pricing structures may be resulting in industry instability, and to clarify and describe the evidence and rationale they are using to support their conclusion;
