Severe wind storm in the winter of 2018 caused extensive damage to our community infrastucture. This affected our remote schools due to road closures and power outages. School emegency lighting is only designed to last 30 minutes so the stranded students were in the dark and parents could not get to the schools due to falling and fallen trees and power lines. The district will formulate a response plan to mittigate the possiblity of future isolation issues, related to storm and earthquake damage.
