WHEREAS:

- A. In accordance with the *Forest Act*, the Licensor and Licensee entered into a replacement agreement for Tree Farm Licence (TFL) 15, dated March 1, 2000 and TFL 35, dated, March 1, 2000, and
- B. The Licensee requested the consolidation of TFL 15 and TFL 35 under Section 39 of the *Forest Act*, and
- C. The Licensor considers the consolidation would not compromise forest management, and
- D. The lands subject to TFL15 are to be deleted from TFL 15 and added to TFL 35, and
- E. The British Columbia Timber Sales volume of 3,594 m³ per year from TFL 15 will be added to TFL 35

THEREFORE:

In accordance with Section 39 of the *Forest Act*, the Licensor, with the consent of the Licensee, agrees to add all lands deleted from TFL 15, under instrument no. 20, to the licence area of TFL 35.

Section 1.09 (a) of the TFL 35 document is amended as follows:

(a) subject to paragraph 1.17, 3,594 m^3 of the allowable annual cut, under non-replaceable timber sale licences; and
