RECOMMEND THAT, pursuant to subsection (1) of Section 15A of the "Placer-Mining Act", as enacted by Chapter 29 of the Statutes of British Columbia, 1944, a reservation be placed upon all minerals in the following lands in the Slooan Mining Division, Namely:

Commencing at the north-east corner of Lot 10391, Kootenay Land District, being a point on the westerly shoreline of Lower Arrow Lake; thence north-westerly in a straight line to the north-east corner of Lot 9881; thence northerly in a straight line to the south-east corner of Lot 8168; thence northerly and westerly along the boundaries of said Lot 8168 to the south-east corner of Lot 9766; thence northerly to the north-east corner thereof; thence northerly in a straight line to the south-east corner of Lot 9886; thence northerly in a straight line to the south-east corner thereof; thence northerly in a straight line to the north-east corner of Lot 9888; thence due north to a point due east of the north-east corner of Lot 9890; thence west to said corner; thence westerly to the north-west corner thereof; thence southerly to the south-west corner of Lot 10028; thence southerly in a straight line to the north-west corner of Lot 9155; thence southerly to the south-west corner thereof; thence southerly in a straight line to the north-west corner of Lot 9765; thence southerly to the south-west corner thereof; thence westerly in a straight line to the north-east corner of Lot 8544; thence due north to the northerly boundary thereof due north 60 chains, thence due west 60 chains; thence due north 80 chains; thence due west to a point 40 chains west of the centre line of Barnes Creek; thence south-easterly in a straight line to the north-west corner of Lot 8544; thence southerly and easterly along the boundaries of said Lot 8544 to the south-east corner thereof; thence easterly and southerly along the northerly and easterly boundaries of Lots 8188, 7894, 7893, and 7892 to the south-west corner of Lot 8546; thence easterly to the south-east corner of Lot 9882; thence north-easterly in a straight line to the south-west corner of Lot 8101; thence easterly to the south-

east corner of Lot 8180, being a point on the westerly shoreline of Lower Arrow Lake; thence in a general north-easterly direction along said shoreline to the point of commencement;
