

Responsibilities for Sellers and Purchasers:

Sellers – this certificate allows you to collect the information and declaration required under the *Provincial Sales Tax Act* (the Act) in order to provide a PST exemption to your customer.

If you do not receive a completed and signed certificate or the required information and declaration before the sale, you must charge and collect PST. Failure to do so may result in an assessment, penalty and interest.

Purchasers – you are responsible for ensuring that you meet all the requirements for the exemption under the Act. If you complete the certificate but you do not qualify for the exemption, you are responsible for paying the PST.

Freedom of Information and Protection of Privacy Act (FOIPPA) The personal information on this form is collected for the purpose of administering the *Provincial Sales Tax Act* under the authority of both this Act and section 26 of the FOIPPA. CERTIFICATE OF EXEMPTION SELF-ASSESSMENT ON SOFTWARE

under the Provincial Sales Tax Act

Instructions:

- This certificate may be used by purchasers who are purchasing software that will be used in the course of their business on or with electronic devices that are ordinarily situated both inside and outside of BC.
- Completion of this certificate allows a purchaser to purchase software from the seller without paying provincial sales tax (PST) on the condition that they self-assess the required PST based on the estimated portion of usage within BC.
- Sellers must keep the completed certificate to show why they did not collect PST on the sale.

I acknowledge that if I make a false statement to avoid paying tax, the *Provincial Sales Tax Act* charges a fine of up to \$10,000 and/or imprisonment up to two years, in addition to a penalty of 25% of the tax due and an assessment for the tax that should have been paid.
