


# Business Search Quick Guide

## Step: Log into BC Registry application and open Business Search

Log into your BC Registry account: <https://www.bcregistry.gov.bc.ca/>

### Help with Business Search

In the Beta version of Business Search you can access documents for the following active and historical business types:

- Benefit Companies
- Cooperative Associations (active only)
- Sole Proprietorships
- General Partnerships

Documents that may be available through Business Search include:

- Business Summary
- Filing History Documents (ledger filings)
- Certificate of Status
- Certificate of Good Standing
- Letter Under Seal

**Note:** The Beta version of Business Search will not retrieve railways, financial institutions, or businesses incorporated under Private Acts.

To access documents for other business types, you will need to search through [BC OnLine](#), or you may [submit a document search request](#).

Field to enter the Business Name, Incorporation or Registration Number, or the CRA Business Number

Search by a business or firm owner; firm owner can be a proprietor or a business that owns a firm
