The Lieutenant-Governor in Council:

The undersigned has the honour to recommend

THAT pursuant to the Mineral Act and Placer-mining Act and all other powers thereunto enabling, no person may locate or mine in or upon all that parcel or tract of land in Victoria Mining Division further described as follows:

Commencing at the southwest corner of Lot 114, Renfrew Land District, being a point on the highwater mark on Juan de Fuca Strait on the southerly shore of Vancouver Island; thence northerly along the westerly boundary of Lot 114 to the northwest corner thereof; thence northeasterly in a straight line to the northwest corner of Lot 274; thence easterly along the northerly boundaries of Lots 274, 273, and 295 to the intersection with a straight line drawn between the southwest corner of Lot 125, Malahat Land District, and the intersection of the westerly boundary of Lot 830 with the northerly boundary of Lot 4, Renfrew Land District; thence southwesterly in a straight line to said intersection of the westerly boundary of Lot 830 with the northerly boundary of Lot 4; thence due south to the highwater mark of Juan de Fuca Strait on the southerly shore of Vancouver Island; thence westerly along said highwater mark to the southwest corner of Lot 114, being the point of commencement; reserving thereout any portion covered by the reserve established under Order in Council No. 1105, April 9th, 1968, Mineral and Placer Acts:

AND TO FURTHER RECOMMEND THAT upon the expiry of any mineral claim, placer-mining claim or lease which lies within the areas outlined above, the lands covered by any such mineral claim, placer-mining claim or lease shall become and are hereby constituted a reservation under the terms of this Order.
