The Sheriff took charge of the jury and recorded ten exhibits. Eleven witnesses were duly sworn in and testified.

PRESIDING CORONER'S COMMENTS:

The following is a brief summary of the circumstances of the death as set out in the evidence presented to the jury at the inquest. The following summary of the evidence as presented at the inquest is to assist the reader to more fully understand the Verdict and Recommendations of the jury. This summary not intended to be considered evidence nor is it intended in any way to replace the jury's verdict.

On August 7, 2007 at approximately 1030 hours, the Kelowna RCMP arrested Michael Lee Stein and a female pursuant to a drug investigation. Mr. Stein reported to the police that he had taken some 'crack' cocaine earlier in the day. Mr. Stein was hand-cuffed and transported in a patrol car to the Kelowna detachment. During the ten minute ride, the officer observed Mr. Stein duck down several times in the back seat. The officer stopped the vehicle and determined that Mr. Stein had ingested approximately 1/8 ounce (8-ball) of crack cocaine. Mr. Stein became agitated at the time. The officer made a radio call requesting that BC Ambulance attend the detachment to conduct a medical check. Specifics of the medical check were not communicated at that time. The ambulance was dispatched as a routine call without emergency lights and sirens. The officer did not determine that Mr. Stein was in medical distress. Mr. Stein arrived at the detachment at approximately 1057 hours. He underwent booking procedures and was escorted to the search room. Mr. Stein became very agitated in the search room and communicated several times to the officer that he had ingested 'crack' cocaine. His distress increased and he complained that he could not breathe and began to scream. The officer spoke to Mr. Stein and asked him to relax and remain calm. Mr. Stein became combative and had to be restrained prone on the floor. The officer had to apply pressure on his back to keep Mr. Stein under control. The officer reported that the applied pressure did not affect his breathing. The ambulance arrived at approximately 1103 hours. Leg irons were placed on Mr. Stein and he was assisted to the gurney to be examined by paramedics. Mr. Stein went into cardiac arrest a very short time after he was placed on the gurney. Resuscitation efforts began immediately and paramedics conducted cardiac protocols. Mr. Stein was transported to Kelowna General Hospital Emergency Department at approximately 1130 hours.

The Emergency Department medical staff provided standard resuscitation measures. Mr. Stein's blood pressure was stabilized, his breathing was assisted and he was transferred to the Intensive Care Unit. Mr. Stein's progress declined in ICU and he died on August 16, 2007. Post mortem and toxicology examinations were conducted. The pathologist did not observe significant trauma or injuries to the body. He reported that the cause of death was respiratory failure due to myocardial infarction as a result of cardiac arrest following ingestion of cocaine. The toxicologist examined antemortem blood samples and determined a cocaine level of 0.02 mg/L and a benzoylecgonine (metabolite) level of 5.80 mg/L. The toxicologist estimated that the ingested dose of 'crack' cocaine was in the range of 2 grams and reported that the findings were consistent with an oral overdose of cocaine.

The Jury deliberated on the evidence and did not offer any recommendations.
