Action

Paper:

Officially launched the PCTIA Paperless Office program.

Notified stakeholders that the Agency's preferred communication method is electronic.

Began revising forms into electronic versions which will be accepted in place of mailed hardcopies.

Agency began assessment of payment options to encourage electronic payments over cheques.

Staff encouraged to collaborate on documents through SharePoint and file electronically.

Meetings 95% paperless (use of laptop/projector instead handouts).

Printer default set to double-sided black and white where printing is unavoidable.

Utilizing email instead of courier where possible.

Travel:

52% of staff take transit or walk to work.

Managerial staff have option of working from home.

Staff encouraged to conduct and attend more webinars and teleconferences (in place of in-person meetings).

Where travel is required, multiple meetings are booked to minimize travel.

Agency applying for Zipcar membership for staff requiring travel for meetings and site visits.

Recycling and conserving energy:

Composted through Growing City organic waste pick up: 240kg of organic waste was diverted from landfill.

Staff continued recycling paper and plastic.

Staff reminded to print only when necessary.

Used reusable dishes during catered meetings.

Staff reminded to turn off lights, computers and other electronics when not in use.

New staff provided with sustainability education during orientation.


