

Executive Council Chambers, Victoria MAY -7.1981

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- 1. The following described lands in the New Westminster and Nanaimo Mining Divisions, Group 2, New Westminster and Nanaimo Land Districts, are established as a mineral reserve and as a placer mining reserve until March 1, 1983. RE: 0/C #266-Feb21/83
  - (a) Commencing at a point 1 650 m north and 400 m west of the northwest corner of Tsawwassen Indian Reserve; thence north 500 m; thence east 6 650 m; thence north 7 200 m; thence east 800 m; thence north 800 m; thence N 550 W 1 200 m, more or less, to the natural boundary of Tilbury Island on the north bank thereof; thence generally southwesterly 1 200 m along the said natural boundary of Tilbury Island; thence south 7 000 m; thence west 6 500 m, more or less, to the mean high water mark of Canoe Pass on the southwesterly shore thereof; thence generally southwesterly along the said mean high water mark of Canoe Pass to a point lying due west of a point 1 650 m north and 400 m west of the northwest corner of Tsawwassen Indian Reserve; thence due east 3 000 m, more or less, to the said point lying 1 650 north and 400 m west of the northwest corner of Tsawwassen Indian Reserve, being the point of commencement.
  - (b) Commencing at the point of intersection of the easterly prolongation of the south boundary of I.R. 3, "Lya-Keen" with the mean high water mark of Valdes Island on the east shore thereof; thence due south 800 m; thence due west 800 m, more or less, to the mean high water mark of Valdes Island on the west shore thereof; thence generally southerly 1 700 m along the said mean high water mark of Valdes Island on the west shore thereof; thence due east 2 700 m, more or less, to the mean high water mark of Valdes Island on the east shore thereof; thence generally northerly 3 000 m along the said mean high water mark of Valdes Island on the east shore thereof to the point of intersection with the easterly prolongation of the south boundary of I.R. 3, "Lya-Keen", being the point of commencement.
