Bob,

Thank you for the clarification. I can confirm that the panel will be provided with a copy of your letter dated May 8th, 2021 which speaks to your request for the Commission to address your licence class and only make a decision on your licence class at this time. However, your marketing intentions for 2021 are also expressed in this letter and I cannot speak for the Commission on if the appointed panel will address anything in addition to Prokam's license class that is written in this letter. In any event, it is clear that you only want the license matter addressed. This will be emphasized and the message will be relayed.

Your comments regarding Blair Lodder's appointment to the panel are unclear and I ask that you clarify. Does your objection to Mr. Lodder's participation on the panel depend on whether the panel addresses your licence class, market access, or both? As written, your email seems to suggest that you object to Mr. Lodder's participation only if the panel considers market access in addition to your licence class. Is that correct?

In any case, could you please also explain the basis for your objection?

Since you do not know how the potatoes Prokam intends to begin planting on June 1 2021 will be marketed, a decision will also need to be made by the Commission at some point before these potatoes can be permitted to enter the market. Prokam is not allowed to market these potatoes except in accordance with the General Order. Furthermore, if Prokam chooses to plant a regulated vegetable without market access it is taking a risk on the production of this product that is conditional on a market access decision that is yet to be issued by the Commission.

Regarding your marketing volume intentions, I noticed in your 2021 producer application that you intend to plant 15 acres of potatoes. However, Your letter dated May 8th refers to planting potatoes based on the delivery allocation calculated by the Commission in the letter dated April 8, 2020. The total delivery allocation as per the April 8th letter is 1,047 tons, which amounts to an estimated 65 acres. Please confirm which number is correct. Once you plant the potatoes you will need to provide a more accurate planted acreage breakdown by potato category.

Your Class 3 licence application for 2021 will be processed but your market access has yet to be determined for the 2021/22 Crop. Furthermore, if the Commission makes a decision to replace your Class 3 licence with a Class I licence, the adjustment will be made and a refund for the difference will be issued.

## Hi Andre

I am not sure what you mean when you say the Commission has struck a panel to address the matter of Prokam Marketing Intentions for 2021. Our understanding was that the only thing to be decided was whether Prokam would be issued a Class 1 license for the upcoming growing season despite the Commission previous order that Prokam would need to grow for two years before its license would revert, and that that would be decided by the reconsideration panel that made that order (which I believe was John Newell, Eric Schlacht, Mike Reed, and Brent Royal). The Class 1 license issue was the only thing we discussed with Debbie, and that was the basis for our May 8 letter.

We have not had a chance to address any other decision that the Commission might be considering

making. All that we hoped to achieve with that letter was to resolve one of the issues between Prokam and the Commission and start to simplify things. There does not need to be any decision right now about how the potatoes Prokam intends to plant will be marketed - that is at least a few months away. We think that issue should be dealt with separately, later on.

Perhaps this is a misunderstanding, and you never intended to suggest that the proposed panel would decide anything other than Prokams license class.

If that is the case, we would only ask that Blair Lodder be removed from the panel, as you propose. We are not sure why the issue isn't being put to the remaining members of the panel that made the Reconsideration Decision, as Debbie said it would, but we do not mind having Armand VanderMeulen instead.
