Act, and upon the recommendation 7.9.18 consent of the Executive Course Pursuant to the Mineral Act and Placer Mining of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council. orders that

- PREEMINER (1) no person shall record or locate upon and no free miner shall stake on or acquire a location in or upon any of the lands within the area described in Schedule "A" attached hereto and made a part hereof which lands are situated in the Vernon Mining Division, Osoyoos Division of the Yale Land District;
- (2) upon the expiry of the term or cancellation of any existing mineral claim, 2 post claim, mining lease, certified mining lease, placer lease or lease issued under the Mineral Act or upon the reversion to the Crown in right of the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no person shall record or locate upon and no free miner shall stake on such lands;

and

(3) with respect to the Placer Mining Act the lands described in Schedule "A" are hereby designated as placer reserves.

Commencing at the northeast corner of the east half of the northwest quarter of Section 1, Township 9; thence southerly along the easterly boundary of said east half of the northwest quarter of Section 1, Township 9, to the southeast corner thereof, said corner being the northwest corner of the west half of the southeast quarter of said Section 1, Township 9; thence easterly and southerly along the northerly and easterly boundaries of said west half of the southeast quarter of Section 1, Township 9, to the southeast corner thereof; thence due south to the westerly boundary of the watershed of the unnamed creek draining King Edward Lake; thence in a generally southerly direction along the said westerly boundary of the watershed of the unnamed creek draining King Edward Lake, to the intersection with the northerly boundary of the watershed of High Lake; thence in a generally westerly and southerly direction along the said northerly boundary of the watershed of High Lake and along the westerly boundaries of the watersheds of Ince Creek and North Oyama Creek to a point, said point being due east of the northeast corner of the northwest quarter of Section 7, Township 10; thence due west to the said northeast corner of the northwest quarter of Section 7, Township 10; thence westerly along the northerly boundary of said Section 7, Township 10 and the northerly boundary of Section 12, Township 14 to the natural boundary of Kalamalka Lake, on the easterly shore thereof; thence in a generally northwesterly, northeasterly, northerly and easterly direction along the said natural boundary of Kalamalka Lake to the northwest corner of the fractional east half of the fractional east half of Section 3, Township 9; thence southerly along the westerly boundary of said fractional east half of the fractional east half of Section 3, Township 9, to the southwest corner of the northeast quarter of the southeast quarter of said Section 3, Township 9; thence easterly along the southerly boundary of said northeast quarter of the southeast quarter of Section 3, Township 9, to the southwest corner of the northwest quarter of the southwest quarter of Section 2, Township 9; thence easterly along the southerly boundary of said northwest quarter of the southwest quarter of Section 2, Township 9, to the easterly boundary of the west half of the west half of said Section 2, Township 9; thence northerly along said easterly boundary of the west half of the west half of Section 2, Township 9, to the southerly boundary of the north half of the north half of said Section 2, Township 9, thence easterly along said southerly boundary of the north half of the north half of Section 2, Township 9, to the northwest corner of the southeast quarter of the northeast quarter of said Section 2, Township 9; thence southerly and easterly along the westerly and southerly boundaries of said southeast quarter of the northeast quarter of Section 2, Township 9, to the southwest corner of the west half of the northwest quarter of aforesaid Section 1, Township 9; thence easterly and northerly along the southerly and easterly boundaries of said west half of the northwest quarter of Section 1, Township 9, to the northwest corner of aforesaid east half of the northwest quarter of Section 1, Township 9; thence easterly to the aforesaid northeast corner of the east half of the northwest quarter of Section 1, Township 9, being the point of commencement; save and except mineral claims King 1 to 4, record numbers 255 to 258 inclusive.
