
Buy a Special Area Licence for Yourself



There are two different special area licences: 1. Gulf Islands Special Area Licence — Persons hunting on the Gulf Islands must have this licence. This special area includes Denman Island, Hornby Island, and all of the islands in MU 1-01, except Vancouver Island. 2. Fraser Valley Special Area Licence — Persons hunting in the Fraser Valley must have this licence. This special area is comprised of MU 2-4 and those areas within MU 2-8 that are within the corporate limits of The Corporation of The District of Maple Ridge, The Corporation of The District of Pitt Meadows, The District of Mission, and The Corporation of the City of Coquitlam Who can buy this licence? 1. Gulf Islands Special Area Licence: Adults (18 or older) 2. Fraser Valley Special Area Licence: Adults (18 or older)




NOTE: If you do not see a "Buy" button, please check your profile and eligibility to buy licences.

Before you start

Before you buy your special area licence, make sure you have:

- A verified, active Fish and Wildlife ID
- An active Residency credential
- A valid public liability and property damage insurance policy in the amount of \$100,000 or more
- Credit card for payment:
 - Gulf Islands SA (Fee: \$2.00)
 - Fraser Valley SA (Fee: \$10.00)

Then click **Buy Licences** under **Licence Options** on your Fish and Wildlife profile.




Choose licence

- A pop-up box will appear
- Select the Licence Year (if applicable)
- Click Add Licence
- Choose the Special Area licence from the dropdown list
- Information about the licence, licence fees, attestation text and insurance information boxes will appear




Complete the attestation

- Before buying the licence, you must confirm that you are covered in the province of B.C. by the appropriate level of insurance, sold by a licensed insurer in the province of B.C.:
 - Gulf Islands SA \$100,000
 - Fraser Valley SA \$1,000,000

NOTE: If you are buying a Gulf Islands special area licence and will be hunting with a licensed guide, you do not require insurance.

- Click the attestation box to confirm
- Enter your Insurance Agency Name
- Enter your Insurance Policy Number
- Click Add to Shopping Cart
- You can then choose to buy another licence or click the
 Proceed to Checkout button




Pay and finish

NOTE: Special Area licences are electronic and are **not** required to be printed. Hunters aged 16 and over must carry photo ID to present to an officer on request.
