IN THE MATTER OF TREE FARM LICENCE NUMBER 23

AMENDMENT NO. 29

BETWEEN:

THE MINISTER OF LANDS AND FORESTS, of the Province of British Columbia, who, with his successors in office is,

hereinafter called "the Licensor" of the one part,

AND

CELGAR LIMITED, a corporation duly incorporated under the laws of the Province of British Columbia, and having its registered office in the City of Vancouver in the said Province,

hereinafter called "the Licensee" of the other part.

WHEREAS by an Indenture made in duplicate on the twentieth day of July in the year of Our Lord One Thousand Nine Hundred and Fifty-Five between the parties hereto, known and referred to as the Arrow Lakes Tree Farm Licence and being numbered twenty-three (23) on the Forest Service register of Tree Farm Licences and on the official atlas maps of the Department of Lands and Forests, the Licensor did grant unto the Licensee the management of certain Crown lands therein described subject to the terms and conditions set forth in the said Indenture:

AND WHEREAS the parties hereto have mutually agreed to amend the said Indenture as hereinafter set forth:

NOW THEREFORE THIS INDENTURE WITNESSETH THAT in consideration of the premises and the sum of One Dollar(\$1.00) of lawful money of Canada now paid by the Licensee to the Licensor, receipt whereof is hereby acknowledged, the parties hereto agree as follows:

THAT Clause 49 of the said Indenture dated July 20th, 1955, (1)be stricken out and replaced by the clause set forth below, which shall be 49 and be of the same force and effect as if such clause had been originally incorporated in the said Indenture in the place and stead of the said Clause 49. The following is the replacing clause:

"49 This tree farm licence shall not be sold or transferred by the Licensee within ten years immediately subsequent to the issuance of this licence without the written consent of the Minister first having been obtained."

(2)THAT Licence Number "721" where it appears in the fourth line from the bottom of page 1 of Schedule "A" of the said Indenture dated July 20th, 1955, being opposite Lot Number "333" is hereby stricken out and "583" inserted in the place and stead thereof.

(3) THAT subject to the terms of this Indenture the parties hereto confirm the said Indenture dated the twentieth day of July 1955, in all other respects.
