AMENDMENT TO SCHEDULE "B" LANDS

BETWEEN:

THE MINISTER OF LANDS, FORESTS, AND WATER RESOURCES of the Province of British Columbia, who, with his successors in office, is

hereinafter called "the Licensor"

OF THE ONE PART,

AND

THE CORPORATION OF THE DISTRICT OF MISSION, a Corporation duly incorporated under the laws of the Province of British Columbia, and having its registered office in the City of Mission in the said Province,

hereinafter called "the Licensee"

OF THE OTHER PART.

WHEREAS by an Agreement dated the 22nd day of July, 1958, the Licensor did grant unto the Licensee a Tree Farm Licence which is known and referred to as the "Mission Municipal Tree Farm Licence" and is numbered twenty-six (26) in the Forest Service register of Tree Farm Licences and on the official atlas maps of the Department of Lands, Forests, and Water Resources.

AND WHEREAS pursuant to Clause 48 of the said Tree Farm Licence the said Agreement may be amended and the parties hereto have mutually agreed to amend the said Agreement as hereinafter set forth:

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration of the premises and the sum of One Dollar (\$1.00) of lawful money of Canada now paid by the Licensee to the Licensor, receipt whereof is hereby acknowledged, the parties hereto agree as follows:

That Schedule "B" be amended by adding the following (1) description:

Block I -

- 25%

"Commencing at the South-West corner of Section 22, Township 15, East of the Coast Meridian, Group 1, New Westminster District; thence South a distance of 80 chains to the South West corner of Section 15; thence East 80 chains to the South East corner of Section 15; thence South 80 chains to the South East corner of Section 10; thence East 160 chains to the South East corner of Section 12; thence North 160 chains to the North East corner of Section 13; thence West 240 chains to the point of commencement".

- (2) That the lands within Schedule "B", shown in Blocks 2, 3, and 4 on the sketch plan dated June 4, 1974, and marked Exhibit "A"; the title and interest to which have reverted to the Crown, shall henceforth be subject to and form part of Schedule B lands of the Tree Farm Licence.
- That the plan attached to the licence as referred to in clause (5) of the licence be amended as shown on the attached plan, dated June 4, 1974, marked Exhibit "A".
- (4) Subject to the terms of this Agreement the parties hereto confirm the said Agreement dated the 22nd day of July, 1958 and prior amendments to the date hereof in all other respects.
- This Agreement shall be binding upon the Minister and his successor in office, and upon the Licensee, its successors and assigns.
