THIS AGREEMENT is made effective the 15 day of March, 2012
BETWEEN:
THE MINISTER OF FORESTS LANDS AND NATURAL RESOURCE OPERATIONS, on behalf of HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA Parliament Buildings Victoria, British Columbia V8V 1X4
(the "Minister")

AND:

WESTERN FOREST PRODUCTS INC.

118-1334 Island Highway Campbell River, British Columbia V8W 8C9

(the "Licensee")

WHEREAS:

- A. In accordance with the *Forest Act*, the Minister and Licensee entered into a replacement agreement for Tree Farm Licensee 19, dated January 1, 2011.
- B. The Minister and the Licensee mutually agree to change the area of Tree Farm Licence 19 by removing Crown lands from the Tree Farm Licence, which will be Crown granted to Western Forest Products Inc.
- C. In exchange, Western Forest Products Inc. will transfer ownership of private lands to the Crown.

THEREFORE:

In accordance with Section 39.1(1) of the *Forest Act*, the Minister with the consent of the Licensee, changes the area of Tree Farm Licence 19 by removing the areas identified as Blocks A, B and C on the attached legal survey plans and Instrument 73 map.

The Minister and the Licensee agree that Schedule A and Schedule B to the Tree Farm Licence 19 agreement is hereby amended to reflect the land deletion described above.

In accordance with the Allowable Annual Cut Administration Regulation, the deletion described above reduces the Allowable Annual Cut of TFL 19 by 1,163 m³/year.
