Climate Action Task Force

Emily Carr has a long history of addressing climate change and sustainability. We are now looking to expand our work and formulate ways to hold ourselves accountable. This includes new strategies, policies and practices to support a university-wide commitment to address the climate crisis. Actions taken include a review of initiatives from various ECU groups over the past decade. This includes the Sustainability Working Group, the 180° Sustainability Group, Creatives with Intent and the DESIS lab. We've also reviewed the metrics and reporting necessary to maintain our building's LEED status. It's



become clear that the Emily Carr community has generated significant resources on sustainability over the past decade. The ad hoc committee recommended that we now establish a Climate Action Task Force to formalize this work and broaden the membership of those involved.

Retirement of Offsets:

In accordance with the requirements of the *Climate Change Accountability Act* and Carbon Neutral Government Regulation, **Emily Carr University of Art + Design** (the Organization) is responsible for arranging for the retirement of the offsets obligation reported above for the 2019 calendar year, together with any adjustments reported for past calendar years (if applicable). The Organization hereby agrees that, in exchange for the Ministry of Environment and Climate Change Strategy (the Ministry) ensuring that these offsets are retired on the Organization's behalf, the Organization will pay the associated invoice to be issued by the Ministry in an amount equal to \$25 per tonne of offsets retired on its behalf plus GST.
