On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- (1) Order in Council 1413 approved May 20, 1964 and Order in Council 3819 approved December 15, 1977 be repealed.
- (2) no free miner shall record or locate upon and no free miner shall stake or acquire a location in or on any of the lands within the following described area in the New Westminster Mining Division, New Westminster Land District:

Commencing at the northwest corner of Township 2, W.C.M.; thence easterly on the north boundary of the said Township 2, W.C.M. and the north boundary of Township 8, E.C.M. to the northwest corner of Section 31, Township 11, E.C.M.; thence easterly on the north boundary of the said Section 31, Township 11, E.C.M. to the northeast corner; thence due east 260 m more or less to the natural boundary of the left bank of the Fraser River; thence easterly on the said natural boundary of the left bank of the Fraser River to the east boundary of Section 12, Township 14, E.C.M.; thence southerly on the said east boundary of Section 12, Township 14, E.C.M. and the east boundary of Section 1, Township 14, E.C.M. to the southeast corner of the northeast 1/4 of the said Section 1, Township 14, E.C.M.; thence southerly in a straight line 1 300 m more or less to the most easterly northeast corner of Section 36, Township 13, E.C.M.; thence southerly on the east boundary of the said Township 13, E.C.M. to the International Boundary; thence westerly on the said International Boundary to the natural boundary of Semiahmoo Bay; thence generally northerly on the said natural boundary of Semiahmoo Bay and the natural boundaries of Boundary Bay and Mud Bay to the west boundary of Township 2, W.C.M.; thence northerly on the west boundary of the said Township 2, W.C.M. to the northwest corner, being the point of commencement.

(3) upon the expiry of the term or cancellation of any existing mineral claim, 2 post claim, mining lease, certified mining lease, placer lease or lease issued under the Mineral Act or upon the reversion to the Crown in right of the Province of any Crown-granted 2 post claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no free miner shall record or locate upon and no free miner shall stake on such lands;
