**PROKAM ENTERPRISES AND CFP MARKETING CORPORATON SUPERVISORY
PROCESS REQUESTS AND DELIVERY ALLOCATION**

I write in response to Ms. Hunter's letter dated January 14, 2020 written on behalf of Prokam Enterprises Ltd. (Prokam) and CFP Marketing Corporation (CFP).

The January letter makes the following requests:

- "...a determination as to the volume of delivery allocation that was transferred to Prokam and whether for purposes of determining Prokam's 2020-21 delivery allocation, the rolling average of Prokam's production should include only production of the delivery allocation by Prokam or whether it should include the production levels of the prior holder of the delivery allocation (Hothi)."
- "...that that Panel communicate to the parties a timeline for completion of the balance of the supervisory review, including the steps that the Panel anticipates taking and the dates by which the Panel anticipates completing those steps. We are hopeful that the supervisory review will be completed within 60 days of the Panel's January 10, 2020 decision.
- "...that the Panel provide representatives of CFP and Prokam with the opportunity to meet with the Panel in person to convey their perspectives on the issues the Supervisory Panel is considering as part of the review."

Delivery Allocation

Any outstanding questions as to the calculation of Prokam's delivery allocation by the BC Vegetable Marketing Commission will be addressed by the supervisory panel as part of its prior approval decision as per paragraph 59(c) in its January 10, 2020 Interim Relief decision¹.

59. In calculating Prokam's delivery allocation for 2020/21, the Vegetable Commission is directed to:

...

c) Submit Prokam's 2020/21 delivery allocation to the panel for prior approval.

The panel received the Vegetable Commission delivery allocation calculation on January 17, 2020 and seeks information from Prokam through correspondence to follow.

Supervisory Review Timeline

Having addressed the issues related to Prokam's immediate business concerns for 2020/21 in the Interim Relief decision, the panel will now turn to establishing the supervisory review process. The panel appreciates Prokam's and CFP's interests in keeping the review timeline as short as possible (60 days).

As previously communicated, the supervisory panel will establish the full supervisory review process once it finalizes the Terms of Reference. As per the panel's November 27, 2019 letter, the draft Terms of Reference will be provided to the Vegetable Commission and the industry for written comment before the document is finalized.

Meeting Request

The panel acknowledges Prokam's and CFP's request for an in-person meeting with the panel. Once the terms of reference have been established, details around participation in the review will be confirmed.
