# PRESIDING CORONER'S COMMENTS

The purpose of these comments is to assist the reader to more fully understand the Verdict of the jury. It is not intended to be considered evidence nor is it intended in any way to replace the jury's verdict.

Brent Andrew Abbott, aged 19 years, was a highly regarded young man in his community. He had worked with his father, a qualified electrician. He enjoyed his family, friends and was active in sports. Mr. Abbott was happily looking forward to becoming an uncle and completing his life skills program. He enjoyed having a few beers with his friends.

Mr. Abbott is missing and presumed dead. He disappeared on Friday, April 29, 2005 at approximately 2030 hours, while in the custody of two RCMP officers at Lytton, BC. He was taken into custody while on the West Side, a rural residential area across the Fraser River from Lytton. He was arrested for being intoxicated in a public place.

The incident began at approximately 2000 hours when an RCMP officer saw a male acting in a suspicious manner in an alley in Lytton, BC. The man fled when the officer approached him. The officer spotted two men a short time later, one of whom he believed was the same individual. The pair ran away and the officer followed them across the CN railway trestle, which spans the Fraser River at the south end of Lytton. The railway trestle has a pedestrian walkway on the up-river or north side of the span, with fencing on either side of the walkway, for pedestrian safety.

The officer eventually located one of the men, identified at Brent Andrew Abbott, on the west side of the Fraser River, hiding in some bushes. He found a quantity of liquor in Mr. Abbott's back pack. Mr. Abbott was of legal drinking age but, according to the officer's statement, was intoxicated. The officer stated that he read him his Charter warning and arrested Mr. Abbott for being intoxicated in a public place. He did not secure Mr. Abbott with handcuffs.

The officer then escorted Mr. Abbott to the railway trestle and they began to walk along the pedestrian walkway, with Mr. Abbott in the lead. A second officer approached them from the east (Lytton) end of the trestle and met them approximately one third of the way from the west side.

As the second officer turned to walk back the way he had come, with Mr. Abbott behind him, followed by the first officer, Mr. Abbott climbed over the north side walkway fence. According to the officers' statements, Mr. Abbott subsequently struck a steel cable running under the trestle with his upper torso or shoulder, before landing in the river more than 100 feet below.

The officers went immediately to the south (downriver) side of the bridge and scanned the water surface for Mr. Abbott, but they did not see any trace of him. Mr. Abbott's baseball cap was later located on a girder under the bridge, at the location where the officers report he jumped.

Extensive air, water and riverbank searches in the following weeks failed to turn up any sign of Mr. Abbott. Further searches in that area were fruitless.

The Inquest heard that at the time of Mr. Abbott's death, it was not uncommon for the youth to be drinking alcohol in and around town and there had been a widespread dislike for the police.
