Declaration statement: This PSO Climate Change Accountability Report for the period January 1, 2022 to December 31, 2022 summarizes our greenhouse gas (GHG) emissions profile, the total offsets to reach net-zero emissions, the actions we have taken in 2022 to minimize our GHG emissions, and our plans to continue reducing emissions in 2023 and beyond.

Emission Reductions: Actions & Plans

A. Stationary Sources (e.g. buildings, power generation)

Consider the following guiding questions:

- 1) FPCC has a strategy to reduce stationary source emissions. Our default printing mode continues to be double-sided.
- 2) To continue reducing stationary emissions, FPCC uses sugar sheet paper which promotes the protection of B.C.'s old-growth forests and vibrant ecosystems. Sugar sheet is 100% recycled, chlorine-free, acid-free paper that lasts longer than regular-use printing paper. We transmit most documents electronically, and we store all our files electronically.
- 3) Our staff regularly conducts meetings via video conference. We continue to turn off lights, small appliances, and electronics at night. We have a motion-activated lighting system to ensure lights are switched off when not in use. Many staff worked from home prior to the COVID-19 pandemic, and many will continue to do so. Our online grant portal eliminates the need associated with freight costs. Our efficient office design maximizes available square footage. Staff are assigned small workspaces with access to "meeting pods" and small meeting rooms.

B. Mobile Sources (e.g. fleet vehicles, off-road/portable equipment)

The FPCC does not use fleet vehicles or off-road / portable equipment.

C. Paper Consumption

- 1) FPCC has a strategy focused on:
 - a. Reducing the number of paper supplies distributed to clients online grant portal applications is preferred.
 - b. Reducing overall paper consumption provided to employees, contractors, the

- 2) FPCC prefers sugar cane paper over recycled paper.
- 3) FPCC is committed to reducing our paper consumption by transferring and storing files electronically.
