

Logging into the modernized Personal Property Registry

Who can access the modernized Personal Property Registry?

Users with Premium accounts who have subscribed to Personal Property Registry (PPR) can access PPR starting on January 25, 2022.

Users who have a Premium account but are not yet subscribed to PPR must add [PPR as a service](#) in their Account Settings.

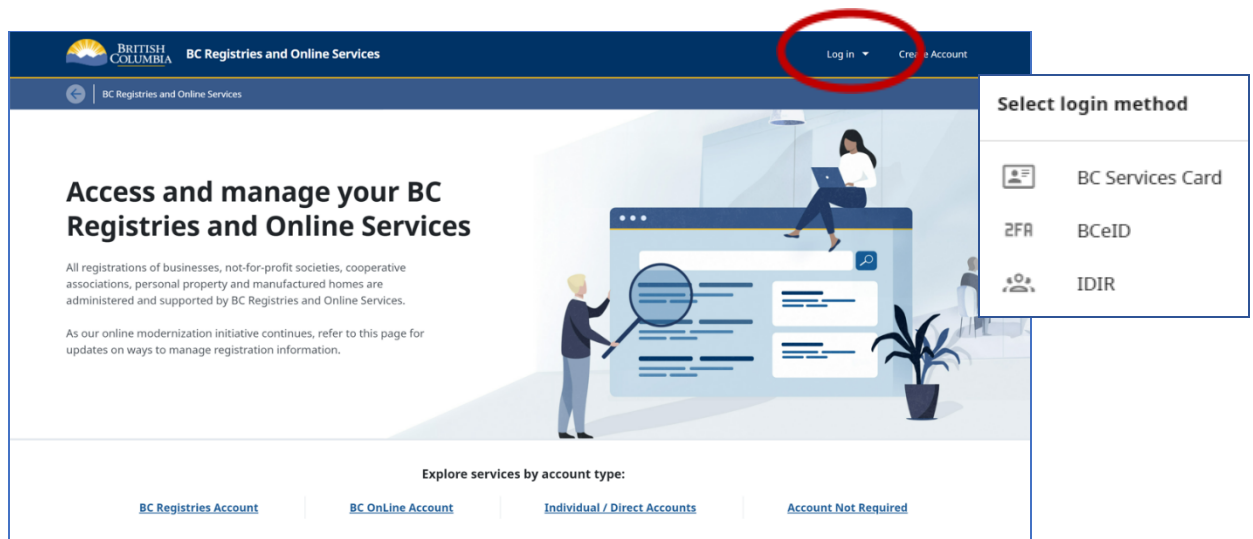
Users without a Premium account must first [set up an account](#) in the BC Registry Application.

How do I access the Personal Property Registry?

To log into the Personal Property Registry, users can click on the “Log in” button in the top-right corner of the [BC Registry Application main page](#), the [Personal Property Registry page](#), or any page within this platform.


Users must select the login method that they used to create their account.

The new BC Registries account supports the following services:

- Business Registry**
Manage the incorporation, registration and listing of businesses and organizations in B.C. Here you are currently able to:

Research and request a name for your new or existing B.C. business. Here you are able to:
 - Search for a business name.

Coming soon to BC Registries account, Wills Registry allows solicitors, notaries and title search companies to do the following:
 - File a wills notice.

Search for Registered Security Agreements and Liens

- Search for legal claims on personal property as well as the people, businesses, and organizations associated with these claims.
- Select registrations to download and view the secured parties, debtors, and collateral in each.
- View and manage your search history.
- Download copies of your Search Result Reports for your records or for use in court.

Note: The Personal Property Registry includes interests in fixtures and crops (personal property attached to land), but does not include ownership and interests in real property (land). Find real property interests in the [Land Title Surveyor Authority \(LTSA\)](#).

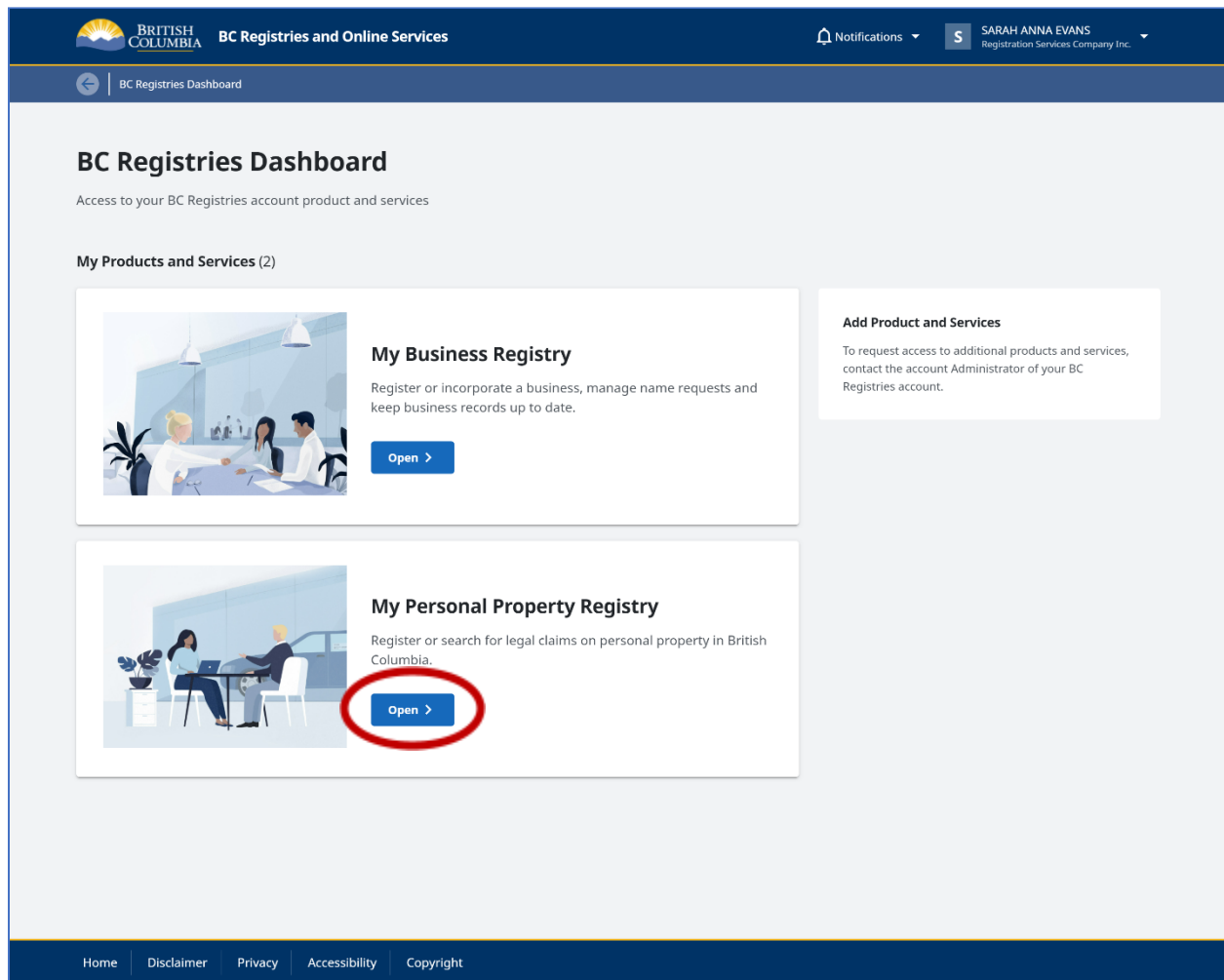
Get Detailed Search Result Reports

- Get a detailed report containing the list of registrations that match your criteria.
- See the current information and complete history of each registration in your report.
- Easily find a particular registration in your report.
- Use your Search Result Report as evidence of a claim, or lack of a claim, on personal property.



BC Registries Dashboard


Once logged in, the BC Registry Dashboard displays services a user is subscribed to.


