BULLETIN**RE: Publication of Designated Inspection Facilities Cancelled for Cause**

Beginning July 7, 2026, the Vehicle Inspection Program will publish a list of Designated Inspection Facilities (DIFs) whose licences have been suspended or cancelled for cause.

This list, included in this bulletin, will be updated on a regular basis. It will only include DIFs which have been suspended or cancelled for cause within the previous 36 months. This list does not include cancellations that occurred due to inactivity, administrative updates, or other non-compliance reasons that do not involve enforcement action.

This measure is intended to:

- Provide greater transparency about enforcement actions taken within the Vehicle Inspection Program
- Support accountability for DIFs responsible for vehicle safety in British Columbia

Facilities listed in this bulletin are not authorized to operate as a DIF or perform vehicle inspections unless otherwise approved by the program. No DIF will be removed from this list unless it is determined necessary by the program.
