THE MINISTER OF LANDS, FORESTS, AND WATER RESOURCES of the Province of British Columbia, who, with his successors in office, is

BOUNDARY SAWMILLS LIMITED, a Corporation duly incorporated under the laws of the Province of British Columbia, and having its registered office in the Town of Midway in the said Province, hereinafter called "the Licensee", OF THE OTHER PART.

WHEREAS by an Indenture dated the 26 th day of January, 1951, the Licensor did grant unto the Licensee a Tree Farm Licence which is known and referred to as the "Boundary Creek Tree Farm Licence" and is numbered eight (8) on the Forest Service register of Tree Farm Licences and on the official atlas maps of the Department of Lands, Forests, and Water Resources;

AND WHEREAS certain errors occurred in the descriptions of the said lands set out in Schedule "B" to the said Tree Farm Licence and the parties hereto have mutually agreed that the said Indenture be amended as hereinafter set forth;

NOW THEREFORE THIS INDENTURE WITNESSETH THAT in consideration of the premises and the sum of One Dollar ( $\$ 1.00$ ) of lawful money of Canada now paid by the Licensee to the Licensor, receipt whereof is hereby acknowledged, the parties hereto agree as follows:

That the said description of Schedule "B" to the said Tree Farm Licence Indenture, dated the 26 th day of January 1951, including any amendment, addition, or other change made therein up to this date are hereby mutually cancelled by the parties hereto and that Schedule "B" as attached to this Indenture and marked Exhibit "A" and dated this. \% Th day of . Opel. . 1968, shall be and is Schedule "B" to the said Tree Farm Licence as if the said lands had been originally described in Schedule "B".
(2) That the Plan referred to in Clause 5 of the said Tree Farm Licence is replaced by the Plan outlined in bold black attached to this Indenture and marked as Exhibit "B", shall be and is the Plan referred to in the said Clause 5 as if the said Plan had been originally attached to the said Tree Farm Licence Indenture.

Subject to the terms of this Indenture the parties hereto confirm the said Indenture dated the 26 th day of January, 1951, and prior amendments to the date hereof in all other respects.
(4) This Indenture shall be binding upon the Licensor and his successors in office, and upon the Licensee, its successors and assigns.

IN WITNESS WHEREOF the Licensor has executed these presents and the Licensee has hereunto affixed its corporate seal by the hands of its proper officers in that behalf.

of said Lot 470 s to the easterly boundary of Lot 2638 s; thence southerly, westerly, northerly and easterly along the easterly, southerly, westerly and northerly boundaries of said Lot 2638 s to the westerly boundary of aforesaid Lot 470 s; thence northerly and easterly along the westerly and northerly boundaries of said Lot 470 s to the southwest corner of Lot 1020 ; thence northerly along the westerly boundary of said Lot 1020 to the southeast corner of Lot 2979 s ; thence westerly along the southerly boundary of said Lot 2979 s to the southwest corncr thercof; thence northerly along the westerly boundaries of Lots $2979 \mathrm{~s}, 2978 \mathrm{~s}$ and 471 s to the northwest corner of said Lot 471 s ; thence easterly and southerly along the northerly and easterly boundaries of Lots $471 \mathrm{~s}, 2983$ and 75 s to the northeast corner of Lot 2977 s ; thence southerly along the easterly boundary of said Lot 2977 s to the northwest corner of Lot 2976 s; thence easterly along the northerly boundaries of Lots 2976 s and 2975 s to the northeast corner of said Lot 2975 s ; thence due east to the westerly boundary of Lot 2839 s; thence northerly and easterly along the westerly and northerly boundaries of said Lot 2839 s to the northeast corner thereof, being the point of commencement."
