### ASSIGNMENT

THIS ASSIGNMENT made the 12th day of December, 1991 to have effect as of the 30th day of December, 1991.

### BETWEEN:

FLETCHER CHALLENGE CANADA LIMITED and CROWN FOREST INDUSTRIES LIMITED, each a corporation subsisting under the laws of British Columbia with an office at 9th Floor, 700 West Georgia Street, Vancouver, British Columbia, V7Y 1J7

(collectively the "Vendors")

#### AND:

INTERNATIONAL FOREST PRODUCTS LIMITED, a company (formed by amalgamation) having an office at Suite 3500, Four Bentall Centre, 1055 Dunsmuir Street, Vancouver, British Columbia, V7X 1H7

(the "Purchaser")

### WHEREAS:

- (C) Each of the Vendors wishes to assign the Agreements to which it is a party to the Purchaser.



- 4. This Assignment is made pursuant to and is subject to the provisions of the Asset Purchase Agreement.
- 5. This Assignment shall enure to the benefit of and be binding on the parties and their respective successors and assigns.
