1) Scope

This document describes procedures for access to a development environment in one of the shared corporate Oracle Designer data model repositories. It represents a consolidation of ILMB, MoE/MAL and MoFR practices.

1.1 Purpose

To model in the Corporate Oracle Data Model Repository there are procedures which must be understood by Business Portfolio Managers (BPM) and developers. The procedures are established by Data Administration (DA) group of the Architecture section in conjunction with the Database Administration (DBA) and Security areas within the Information Management Branch (IMB). This document provides access procedures and information to start modelling in any of the Corporate Oracle Data Model Repositories.

1.2 Audience

The audience for this document is primarily vendors on contract with the Natural Resource Sector (NRS), who are developing data models for the business clients and BPM's that are guiding development.

1.3 Assumptions

It is assumed that developers have formal training in data model development. It is also assumed that developers understand application development and the Systems Development Lifecycle (SDLC).

2) Corporate Model Repositories

Data Administration manages 3 separate model repositories, all at Oracle release 10.1.2.4.

Determination of which repository a **new** project should utilize will be determined at the technical <u>White Board Session</u>. Existing applications developed in the former MoE/MAL will continue to use RDRPROD1. Existing applications developed in the former MoFR repository will continue to use DBC05. Applications transferred from ILMB will use the NRSMR1 repository.

3) Access Procedures

Only a named IDIR/BCeID user will be given an Oracle UserID to access an Oracle repository. Government policy mandates that any userID and passwords are not to be shared with others.

3.1 Developers

- For new IDIR accounts, developers must contact the CSNR BPM/BA for the specific project to acquire an <u>IDIR account</u> and VPN access, and <u>Oracle UserID</u>.
- Developers requiring <u>update</u> access to specific Models in the repositories must request access through the appropriate CSNR BPM/BA for that project.

3.2 BPMs/Bas

- To request creation of a <u>new Oracle UserId</u> for a developer in one of the model repositories, BPMs should provide Data Administration with the following information:
 - Application acronym
 - Developer's full name
 - Telephone number(s)
 - IDIR account
 - Org Unit
 - Model repository Database(s)
 - o Expiry date
 - Email address
- To request access to one or more models in the repositories for developers with an existing Oracle Userid, BPMs should provide Data Administration with the following information:
 - Application acronym
 - o Developer name, telephone number, and Email address
 - IDIR account
 - Oracle UserID

4) Required Reading

A developer new to the Natural Resource Sector's Oracle modelling environment must read the following documents before undertaking any application changes:

- Data Modelling Standards
- Naming Standards (includes codes)
- Developers Working in a Versioned Oracle Designer Repository

NOTE: As there are no procedures needed for working in a non-versioned Oracle Designer repository, no documentation is required.

APPENDIX C – Software Version of Repositories

Currently used within NRS, Oracle Designer software is at the Oracle 10g patch release 10.1.2.4.

NOTE: Obtaining the current Oracle release on the Oracle website will not be compatible with the NRS repository environment.

The full IDS software package must be installed first, followed by installing the patch for Designer. Also a reports patch is required for reports to function properly. The client software license is free from Oracle for doing development work, but developers must register with Oracle by downloading the latest patch. Oracle does not provide archived patches so the patches mentioned above are available on our intranet at:
