The undersigned has the honour to recommend that, pursuant to subsection (5) of section 12 of the "Mineral Act", Chapter 244, Revised Statutes of British Columbia, 1960, as amended by Chapter 39, Statutes of British Columbia, 1961, and Chapter 39, Statutes of British Columbia, 1962, and section 11 of the "Placer-Mining Act", Chapter 285, Revised Statutes of British Columbia, 1960, no person may locate or mine upon the following described areas in the New Westminster Mining Division for any mineral therein:-

- Area 1: Fractional Section 25 of Fractional Township west of Township 39, New Westminster District.
- Area 2: Sections 12, 13, 14, 15, 22, 23, 24, 25, Fractional Sections 26, 27, 34, 35 and 36, Township 1, West of the Coast Meridian; Sections 1 to 24 inclusive and Sections 26 to 32 inclusive; Township 7, East of the Coast Meridian; Sections 5 to 8 inclusive and Section 18, Township 10, East of the Coast Meridian; and Lots 153, 244, 154, 165, 155, 450, 161, 162, 163 and 164, Group 2, New Westminster District.
