The undersigned has the honour to recommend

THAT Order in Council No. 1768, approved on May 30th, 1967, be rescinded:

AND TO RECOMMEND THAT pursuant to the Mineral Act and Placer-mining Act and all other powers thereunto enabling no person may locate or mine upon the following described area in the Vancouver Mining Division, Group 1, New Westminster Land District:

Commencing at the northeast corner of Lot 1145, Group 1, New Westminster District; thence southerly and westerly along the easterly and southerly boundaries of said Lot 1145 to the northeast corner of Lot 1132; thence southerly and westerly along the easterly and southerly boundaries of said Lot 1132 to the southeast corner of Lot 1131; thence westerly along the southerly boundaries of said Lot 1131 and Lot 1130 to the northeast corner of Lot 1124; thence southerly and westerly along the easterly and southerly boundaries of said Lot 1124 to the southeast corner of Lot 1125; thence westerly along the southerly boundaries of said Lot 1125 and Lot 1126 to the southwest corner thereof; thence northerly along the westerly boundary of said Lot 1126 to the southeast corner of Lot 1344; thence westerly and northerly along the southerly and westerly boundaries of said Lot 1344 to the northeast corner of Lot 949; thence westerly along the northerly boundary of said Lot 949 a distance of 40 chains; thence due south to the southerly boundary of said Lot 949; thence westerly and northerly along the southerly and westerly boundaries of said Lot 949 to the northeast corner of Lot 1496; thence westerly along the northerly boundary of said Lot 1496 to the northwest corner thereof; thence northerly along the easterly boundaries of Lots 1494 and 1495 to the northeast corner thereof; thence westerly along the northerly boundary of said Lot 1495 to the southeast corner of Lot 2386; thence northerly along the easterly boundary of said Lot 2386 to the northeast corner thereof; thence easterly and northerly along the southerly and easterly boundaries of Lot 2361 to the most nor therly northeast corner thereof; thence easterly and northerly along the southerly and easterly boundaries of Lot 2365 to the northeast corner thereof; thence easterly and northerly along the southerly and easterly boundaries of Lot 2817 to the southwest corner of Lot 2818; thence easterly along the southerly boundary of said Lot 2818 to the southeast corner thereof; thence due east to a point lying on the northerly boundary of
