On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that B.C. Reg. 625/75 be repealed and the following order be made:

1. No free miner shall

(a) record or locate a mineral claim, or

(b) stake or acquire a location on the area in the Vancouver Mining Division, Group 1 New Westminster Land District:

Commencing at the northwest corner of lot 4755; thence easterly along the north boundary of said lot 4755 to the northeast corner thereof; thence northerly and easterly along the west and north boundaries of lot 3861 to the northeast corner thereof; thence easterly in a straight line to the southwest corner of lot 4104; thence northerly, easterly, northerly, easterly and southerly along the west, north, west, north and east boundaries of said lot 4104 to the northwest corner of lot 3363; thence easterly along the north boundary of said lot 3363 to the northeast corner thereof; thence southerly 396 m along the east boundary of lot 3363; thence due east to a point lying due north of the point of intersection of the east boundary of lot 1940 and the northerly limit of the British Columbia Railway right-of-way as constructed on the ground; thence due south to said point of intersection; thence in a general southerly direction along the east boundary of lot 1940 to the most southerly corner thereof; thence northerly, westerly, northerly, westerly and northerly along the west, south, west, south and west boundaries of lot 1940 to the point of intersection with the southerly limit of the aforesaid British Columbia Railway right-of-way as constructed on the ground; thence northwesterly in a straight line to the southeast corner of aforesaid lot 3363; thence westerly along the south boundary of lot 3363 to the northeast corner of lot 3674; thence southerly along the east boundary of said lot 3674 to the southeast corner thereof; thence S 10° E 675 m, more or less, to a northwest corner of Garibaldi Provincial Park; thence southerly, easterly, southerly, easterly, southerly, westerly, southerly westerly, southerly and westerly along the west boundary of said Garibaldi Provincial Park to a point, said point being an internal angle on the boundary of Garibaldi Provincial Park situated approximately 3 960 m due south and 200 m due east of the southeast corner of lot 5316; thence due west to a point lying due south of the southeast corner of lot 2291, thence due north 1 580 m; thence due west 4 750 m; thence due north 1 980 m; thence northeasterly in a straight line to the northwest corner of lot 2246; thence due north to a point lying due west of the aforesaid northwest corner of lot 4755; thence due east to the said northwest corner of lot 4755 being the point of commencement.
