

**WILLIAMS LAKE BAND**  
**Forest & Range Consultation and Revenue Sharing Agreement (FCRSA)**  
**(The “Agreement”)**  
**Amendment Agreement #1**

**WHEREAS:**

- A. The parties entered into the Agreement on January 11, 2017.
- B. The parties wish to amend the Agreement as set out in this Amendment Agreement #1.

**THEREFORE:**

The parties agree to amend the Agreement as follows:

- 1. Section 14 is amended as follows:
  - 14.1 The Agreement will end on March 31, 2022.
- 2. Appendix C Section 1.3 is amended as follows:
  - 1.3 The Traditional Territory Forest Revenue Sharing Component will be calculated by multiplying 5 percent of the forest revenue attributed to the Williams Lake Band as described in section 1.2 of this Appendix.
- 3. Appendix C Section 2.1 is amended as follows:
  - 2.1 The Direct Award Forest Tenure Revenue Sharing Component will be calculated by multiplying 75% of the forest revenue as described in section 2.0 of this Appendix.
- 4. Appendix C Section 3.2 is amended as follows:
  - 3.2 For each BC Fiscal Year that this Agreement is in effect, the remaining portion of the Revenue Sharing Contribution is calculated by determining the value of the payments that were made by British Columbia to Williams Lake Indian Band in any given full year under the Williams Lake Band Forest and Range Opportunity Agreement (“the Annual Amount”) and applying the following percentages to that Annual Amount:
    - 3.2.1 2018/2019 BC Fiscal Year: 40 percent;
    - 3.2.2 2019/2020 BC Fiscal Year: 40 percent;
    - 3.2.3 2020/2021 BC Fiscal Year: TBD, and;
    - 3.2.4 2021/2022 BC Fiscal Year: TBD.

5. Appendix C Section 3.3 Change BC Fiscal Years 2014/15 and 2015/16 to 2018/19 and 2019/20, respectively.

6. Appendix E is amended as follows:

2015/2016, 2016/2017, and 2017/2018 are updated with 2018/2019, 2019/2020 and 2020/2021, respectively.

7. Appendix F is amended as follows:


2016/2017 and 2017/2018 are updated with 2018/2019 and 2019/2020, respectively.


