Re: Supervisory Review – Evidence of Mr. Brian Meyer

Please bring this letter to the attention of Chair Donkers.

I write concerning the evidence of Mr. Brian Meyer, who I interviewed on December 8, 2021. We have been informed by Mr. Meyer that he has been experiencing serious health issues, including open heart surgery in 2019, followed by a diagnosis of stage 4 metastatic cancer for which he is receiving ongoing treatment. As a result, Mr. Meyer has advised us that he is unable to appear as a witness in the hearing.

Accordingly, we have commissioned the enclosed affidavit of Mr. Meyer, commissioned on January 28, 2022 ("Meyer Affidavit"), which I seek to have admitted as evidence in this Supervisory Review.

Rules 24 and 25 provide as follows:

- 24. The Review Panel may receive any evidence considered helpful in fulfilling the Terms of Reference in the Supervisory Review. The strict rules of evidence used in a court of law to determine admissibility of evidence will not apply.
- 25. Witnesses who testify will give their evidence under oath or upon affirmation. However, the Review Panel is entitled to receive relevant evidence at the Oral Hearing even where no oath or affirmation has been given after affording all counsel and participants [the opportunity] to make submissions.

In light of these Rules, it is my position that the Meyer Affidavit should be admitted, and the lack of an opportunity for the participants to cross-examine Mr. Meyer on his evidence should go to the question of weight.

With respect to a fair process for dealing with this application, I have already advised the participants that I am concerned about the time we have available in the oral hearing, particularly in light of the volume of documents that are now involved. As a result, I propose that this application be dealt with by way of written submissions. Specifically, I propose that any participant who wishes to provide written submissions do so by 8:00 am on Tuesday, February 1, 2022, and that any such submissions be limited to three (3) pages or less. For clarity, I will not be providing further submissions on this application.
