EXECUTIVE COUNCIL CHAMBERS, VICTORIA AUG. 17.1978

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

(1) no free miner shall record or locate upon and no free miner shall stake or acquire a location in or on any of the lands within the following described area in the Cariboo Mining Division, Cariboo Land District, in the period commencing on the date of approval of this order and terminating July 31,

Commencing at the intersection of the west boundary of Lot 1920 and the natural boundary of the left bank of South Hawks Creek; thence northwesterly on the said natural boundary of the left bank of South Hawks Creek to the south boundary of Indian Reserve #2 "Deep Creek"; thence westerly on the said south boundary of Indian Reserve #2 "Deep Creek" 1 375 m; thence south 875 m; thence east 700 m; thence south 1 050 m; thence west 700 m; thence south 325 m; thence easterly 4 500 m, more or less, to the intersection of the west boundary of Lot 1920 and the natural boundary of the left bank of South Hawks Creek, being the point of commencement.

(2) upon the expiry of the term or cancellation of any existing mineral claim, 2 post claim, mining lease, certified mining lease, placer lease or lease issued under the Mineral Act or upon the reversion to the Crown in right of the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no free miner shall record or locate upon and no free miner shall stake on such lands;

and

(3) with respect to the Placer Mining Act the lands described above are hereby designated as placer reserves.
