 - c. within British Columbia issuing any certificate indicating or implying that the holder is a doctor entitled to practise as a doctor;
 - d. within British Columbia offering to issue such a certificate, or advertising that such a certificate will be issued, on completion of any programme or other requirements.
- 2. the Plaintiffs are not required to give an undertaking to abide by any order the Court may make as to damages.
