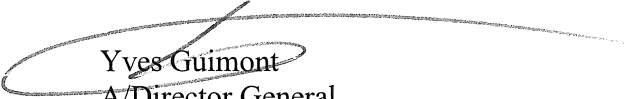

Thank you for your letter of May 4, 2015, regarding the Coroner's Inquest into the death of Ryan Allen Walter Jacob. BC Emergency Health Services (BCEHS) has reviewed the verdict and the jury recommendation regarding the BC Ambulance Service (BCAS). As a result of this review, we are pleased to provide the following response.

Recommendation #1: Advanced Life Saving (ALS) Units: the recommendation of the jury is that the Provincial Health Ministry, in consultation with Provincial Health Authority investigate the addition of more ALS units to the coverage area.

BCEHS is continually examining, through evidence-based research, how best to apply limited resources to provide the best patient care possible. It is a primary goal of BCEHS that every patient receives the right care, by the right provider, at the right time. To ensure that Advanced Life Support (ALS) crews are available when patients require their specialized training, BCAS has developed a sophisticated resource allocation plan based on the international standard Medical Priority Dispatch System. This plan allows dispatchers to readily determine what type of response is required for any medical emergency. The goal is to reserve ALS crews for those situations where they are most needed and it is structured to send these highly trained paramedics to calls where there is even a small chance that they will be required.

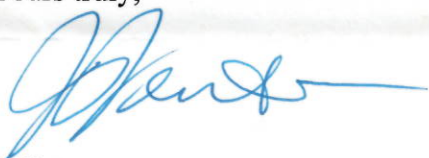
Communities with a significant volume of calls requiring ALS, such as Burnaby, are provided with ALS resources and the support required to maintain their skills. The resources provided to each community are regularly reviewed in order to ensure that the community's needs are being met appropriately. We are currently in the midst of a major review of how BCEHS resources can be most effectively deployed, with a particular focus on ground ambulance services in Metro Vancouver and Victoria.

While we would welcome the ability to increase coverage in every community, ALS units are a limited resource, and this is simply not feasible.

In this case, paramedics responded appropriately and in a timely fashion. A Basic Life Support crew was at the scene within six minutes, and an ALS crew arrived less than four minutes afterward. Mr. Jacob had suffered a major penetrating chest trauma, and required rapid and immediate transport to hospital. This was initiated. The ALS crew provided advanced assessment and treatment appropriate to their level; however, this did not improve his condition. There is no clinical evidence to suggest that earlier ALS attendance would have made a difference as to the outcome.

Again, thank you for bringing this matter to our attention.
