Pursuant to Section 38 of the Coroners Act, the following recommendations are forwarded to the Chief Coroner of the Province of British Columbia for distribution to the appropriate agency:

JURY RECOMMENDATIONS:

To: The Royal Canadian Mounted Police (RCMP) and the Independent Investigations Office (IIO):

1. Review and clarify policy and procedures with respect to officer safety and evidence collection after an incident in which the IIO and the RCMP are involved.

To: E-Comm 911:

2. Review current policies and practices to ensure that, where a shot is fired, or there is other information or actions of such significance, this information is relayed to all responding agencies, including BC Emergency Health Services, Police and the Fire Department.

To: The Royal Canadian Mounted Police:

3. Review and improve support services for members involved in an IIO investigation.
4. Review and improve support services for members involved in any serious or traumatic incidents.
5. Review and improve practices and policies related to the deployment of non-lethal methods, including police dog units, to incidents involving weapons.
6. Review and improve de-briefing methods related to the specific events and outcomes of serious and traumatic incidents.

To: All Emergency Service Agencies (E-Comm 911, Police, Fire, Ambulance)

7. Review and improve integrated training exercises for incident responses that involve multiple agencies.
8. Review and improve incident command training.

To: The Municipality of Burnaby

9. Review by-laws regarding the visibility of residential addresses from the street.
