Pursuant to Section 38 of the Coroners Act, the following recommendations are forwarded to the Chief Coroner of the Province of British Columbia for distribution to the appropriate agency:

#### **JURY RECOMMENDATIONS:**

#### To: RCMP "E" Division and Detachment Commander of the Dawson Creek RCMP

1. A policy to require any member authorizing or conducting a strip search to review current related RCMP procedure prior to such search.

### To: RCMP "E" Division

2. Creation of a visual strip search training guide including the positioning of a detainee's body and handling of their clothes during such search.

#### To: Detachment Commander of the Dawson Creek RCMP

3. Recommend guards are informed they have the discretion to request an additional guard(s).
